5. An affidavit to the effect that their firm/agency has not been blacklisted by any Govt./Authority/Department executed on stamp paper duly attested.

The Bidder/Authorized signatory should submit Earnest Money/Bank Guarantee amounting to Rs.75,000/- in the form of Fixed Deposit Receipt, or Bank Guarantee from any commercial bank in favour of State Project Director, Samagra Shiksha-Delhi before the last date of bid submission in the office of Samagra Shiksha- Delhi.
