## **Technical Terms & Conditions**

1 The agency shall submit the following documents along with quotation:-

- i) Self attested copy of GST Registration of the Company /Firm.
- ii) An Undertaking to the effect that the Agency has not been blacklisted by any of the Department/ Organizations /autonomous bodies/ undertaking of the Govt. of India/Government of NCT of Delhi and no criminal case is pending against the said firm/agency.

2. Each and every document submitted along with the quotation should be signed by the Prop./partner/Authorized signatory.

3. Any person who is in Government service or an employee of the Department should not be made a partner to the contract, by the tenderer directly or indirectly in any manner whatsoever.

4. The tenderer shall require completing the said work on priority after issuance of work order or as desired in the order, failing which Performance Security submitted by the firm shall be forfeited.

5. The Department reserves the right to cancel the tender or to withhold payment in the event of non-commencement or unsatisfactory performance by the agency. In such an eventuality, the Department further reserves the right to get the work done from open market at the cost of the agency. Agency may be blacklisted by the Government for a period of three years to participate in any type of tender & his security money shall also be forfeited.

6. If any information furnished by agency is found to be incorrect or false at any time, the tender will be liable to be terminated without any notice and the security deposit is liable to be forfeited including black listing of agency.

7. The Department reserves the right to terminate the tender at any time without assigning any reason.

8. The agency shall indemnify the Department against all damages/charges and expenses for which the Government may be held liable to pay on account of the negligence of the agency or any person under his control whether in respect of accident, injury to the person or damages to the property of this department or any member of the public or any person or in executing the work or otherwise and against all damages and demands thereof.

9. In the event of specified date of opening of tender having been declared as a holiday, the tender shall be opened at the same place and same time on next working day.

10. In the event of any dispute arising out in connection with the interpretation of any clause in the terms & condition of the NIQ, or otherwise the matter shall be

referred to the Arbitrator nominated by the Chief Secretary, Delhi. The Courts at Delhi/New Delhi shall have the exclusive jurisdiction in connection with any dispute/litigation arising out of this tender.
