CIRCULAR

Subject- Fund Allocation and sanction of Rs 2,03,80,000/- for organisation of Sports Day in all schools of Directorate of Education Samagra Shiksha 2019-20 @ Rs 20,000/- per school.

Health and Physical Education is an integral part of school curriculum in schools of Directorate of Education, it will strengthen the overall physical as well as mental development of the students. To promote games and sports, this year **Sports Day** will be organised in Govt. Schools of Directorate of Education under Samgra Shiksha for year 2019-20.

For the smooth conduct of Sports Day in all Govt. schools of Directorate of Education, the competent authority has approved the amount of Rs 2,03,80,000 /- (Rupees Two Crore three Lac Eighty Thousand only) **@ Rs 20,000/- per school.** The details of District wise sanctioned amount/allocated fund is given here as under:

The guidelines for organization of the Sports Day in Govt. Schools of Directorate of Education are as follows:-

1. DDE/DPO of concerned District will be overall incharge and ensure proper utilization of funds and submit zone wise U/C to DDE,SS
2. SPE Zone will coordinate with all the schools of their respective zone for effective organization of Sports Day.
3. The Head of the school shall spread awareness through morning assembly and SMC Members about the significance of Sports Participation.
4. The event shall be so designed to promote mass participation at all levels viz; Primary, Middle, Secondary and Senior Secondary.
5. Physical Education Teacher will serve as role model through group activities, i.e Dumbbells, Lazium, Hoops, Marching, Aerobics, Self Defence etc. will demonstrate knowledge of health, physical education and wellness.
6. Apart from Major Games and Athletic events, inclusion of Minor Games and fun games will promote joyful learning.
7. While organizing Sports Day, safety measures must be kept in mind:-
 - i. Leveled Sports grounds with proper making.
 - ii. Students shall be allowed to participate in Sports Kit.

- iii. Case History of any disease of the participating must be viewed and taken care of.
- iv. First Aid Box with necessary medicines shall be available to meet out the emergency conditions.
- v. Service of other staff members may be utilized for effective organization of the programme.
- vi. The Sports Day must be organized on or before 30-11-2019.

All the District Project Officers/DDE's are directed to ensure that the Sports Day must be organized in all Govt. Schools of Directorate of Education in their respective districts till November 2019 and submit zone wise Utilization Certificate following all codal formalities under GFR 2017 and all financial guidelines issued by GOI and GNCTD from time to time, in first week of December 2019 to the undersigned after successful completion of the Sports Day.
