Under-14 (Boys)	05.11.2019	Player should be born on or after 01.01.2006 and should be a student of upto Class XII but not below Class VI.
Under-14 (Girls)	06.11.2019	-Do

Note: In team events maximum 05 players and minimum 03 players are compulsory in both Boys & Girls.

- (a) The copy of birth certificate of the student, issued by the Municipal Authority within one year of the birth of the child, is to be enclosed. If it has been issued after one year of the birth of the child, then it has to be supported with the orders of the Competent Authority e.g. SDM of the area concerned.
- (b) In case of need, a student might have to undergo medical examination for age verification from the Govt. hospital.

- (c) In case of any dispute, protest can be lodged with protest fees of Rs.500/-, within one hour of completion of the match. No request would be allowed after the stipulated time.
- (d) Decision of the Technical Committee would be final.

The Zonal Supervisor / Convener should send the entry of their respective zones in the enclosed prescribed proforma at Annexure-III, duly attested by the Competent Authority latest by 25.10.2019 at Thyagraj Stadium, INA, New Delhi. The teams / players will have to report in the proper playing kit.

- a. Only Delhi Government schools, Governemnt aided schools and schools recognized by this Directorate are allowed to participate in this tournament.
- b. The copy of birth certificate of the student, issued by the Municipal Authority within one year of the birth of the child, is to be enclosed. If it has been issued after one year of the birth of the child, then it has to be supported with the orders of the Competent Authority e.g. SDM of the area concerned.
- c. In case of need, a student might have to undergo medical examination for age verification from the Govt. hospital.
- d. Players who are in the same age group category in which they won medals in the 64th National School Games and current Delhi State ranking No.1 & 2, also current National Ranking holder upto 4th are allowed to play directly in the super league stage, if they submit their documents and request letter in writing before the trials. This rule will apply in all age categories.

- e. Players can give trials in same age categories in which they are eligible as per SGFI Rules.
- f. For Inter zonal team championship 1st & 2nd round matches will be played best of 3 games and from the quarter final matches will be played best of 5 games. As per SGFI Rules.
- g. Only those players who played in Delhi State /Zonal and Inter-Zonal are eligible for selection trials for National School Games.
- h. All the participants should bring their original Date of Birth proof (mandatory). No player will be allowed without ID proof. Please bring original and duly attested individual entry form with recent photograph (as per Annexure-I).
- i. All players should have mandatory AADHAAR Number.

j. A player can participate in only one age category in that particular year.
