Guidelines for organizing District Level Celebration of International Day of Persons with Disabilities (IDPD)

1. District Level International Day of Persons with Disabilities (IDPD) shall be organized in 12 Districts of DoE, Delhi for students with disabilities studying in Pre-School to Class XII in schools that come under Samagra Shiksha latest by 5th March 2021.
2. The activities given in Dept'al circular no. F.311/DDE(IEDSS)/Admn.Cell/Pt.file/2018/3359-72 dated 25/11/2020 for school level celebration of IDPD may be organized at district level also. Further, in each activity, students who achieve first, second and third positions shall be given prize. The items which are useful for students in learning shall be selected as prize.
3. NOC from the parents of participating CWSN who will be attending the District Level celebration of International Day of Persons with Disabilities may be obtained in advance.
4. DPO/DDE (District) shall ensure the availability of approved fund to Officers/ Officials/District Coordinator in advance to make all suitable preparatory arrangements at the venue, so that the students with disabilities don't face any difficulties at the venue. Further, it may also be ensured that the expenditure should not exceed the allotted fund by Competent Authority.
5. Even though maximum number of participating CWSN in each district is given in Annexure- II, the same is to be decided by concerned DPO based on the COVID-19 guidelines and sitting capacity of venue. However, consolation prize and refreshment (except conveyance) shall be provided to CWSN who didn't physically attend the programme at venue through concerned HOS, as per approval for said district.
6. Program venue to be identified by DDE (District)/DPOs by considering the guidelines related to COVID-19 conditions issued by MHA, Gol while organizing the programme.
7. The HOS of the concerned school where the District Level International Day of Persons with Disabilities is being organized are hereby directed to cooperate and provide full necessary assistance for the smooth organization of the said programme.
8. The concerned district shall ensure that resources/infrastructure available at the venue including availability sitting arrangement; public utility etc. shall be as per the norms of social distancing.
9. Thermal scanning of participating students shall be done at the entry gate itself. Any person found to be symptomatic shall not be allowed to enter the premises of the venue.
10. Sanitizers shall be made available to the participating students and their parents/escort. Fund allocated towards contingency may be used towards purchase of sanitizing material.
11. Adequate staff may be deployed to ensure proper discipline and smooth functioning of the programme.
12. Nodal Resource Person (CWSNs)/RP (CWSN) will ensure the participation of CWSN from DCB, MCD, NDMC, MCD Aided, and NDMC Aided schools in the District Level International Day of Persons with Disabilities (Pre-School to Class XII) for 2020-21.
13. District Coordinators (IE) shall submit report of celebration of IDPD along with the details of prize winners to this office within one week of its completion.
14. Safety and security of students shall be accorded highest priority.
