ORDER

Subject: Re-engagement of thirty five Upper Primary Teachers on contractual basis under Samagra Shiksha-Delhi to work in government schools of Directorate of Education.-Reg.

As per the Framework for Implementation of Samagra Shiksha, an integrated scheme for School Education, quality of teaching depends on teachers and teacher's deployment need to align with the vision of quality education and to inculcate healthy classroom transaction. A teacher has to perform its duties as per the Section 24(1) of RTE, Act 2009.

Further Programmatic and Financial Norm of Samagra Shiksha scheme, provide financial assistance to the state/UT/towards the salary of teachers to ensure maintenance of PTR norms at the school level. In this connection, some Upper Primary Teachers, including language teachers, signed Agreement on contractual basis with the Deputy Directors of Education/DPOs of various districts to work in government, schools of Directorate of Education, Delhi for the period from 01.09.2020 to 19.01.2021 only, on the terms and conditions contained in Agreement. Later, such Upper Primary Teachers were allocated schools, to work as the Guest Teachers vide Order No. 18.2(65)/E-V/2020/167-172 dated 11.02.2021, by Directorate of Education, Delhi. But many of such Guest Teachers, were further stand relieved on account of joining of regular teachers. Thirty five number of such relieved Guest Teachers submitted their representation with the request to provide them an opportunity to re-engage as Upper Primary Teachers on contractual basis under Samagra Shiksha-Delhi and their request was considered and now has been accepted by the Secretary (Education) cum President Executive Committee, Samagra Shiksha-Delhi.

Considering the above, the following Upper Primary Teachers are hereby re-engaged as subject teachers mentioned against their names, on the same terms and conditions as contained in the agreement, last signed jointly by the candidate and District Project Officer of the respective district:
