CIRCULAR

Subject: Art Exhibition cum Competition for the students of primary classes for the session 2024-25.

To enhance the quality of education at primary level and to create a conducive environment for learning, a number of initiatives have been introduced by Nursery Primary Branch. Observation shows that students tend to excel when their work is acknowledged and ignites a powerful boost to their self-esteem and performance.

In continuation of the last year's competition and exhibition and as detailed in the Annual school calendar vide circular no. DE.23(544)/Sch.Br./2024/171 dated 11/03/2024, Art exhibition-cum-Competition is to be organized on different levels featuring paintings by primary students, which is a wonderful and creative event. It is a great way to showcase young talent and encourage their artistic expression.

Exhibiting these paintings/drawings created by students of primary classes have numerous benefits, as it provides a platform for self-expression, boosts confidence, a sense of accomplishment, communication skills to articulate their thoughts and ideas, fosters cultural appreciation and understanding, nurtures creativity and imagination, and inspires them to explore their artistic talents.

In the light of the above, the Competent Authority has decided to organize **School level Art Exhibition cum Competition for the students of primary classes (3rd to 5th) for all Sarvodaya Vidyalaya under DoE.**

General Guidelines for the schools:

1. The schools will provide complete guidance and ample opportunity for practice to all the students of primary classes for better participation in the school level painting/ drawing competition.
2. The participation of the students must be restricted for primary classes (3rd to 5th) only.
3. Any medium i.e. sketch pen, oil pastels, water colour, mix media etc. can be used.
4. Only A3 size sheets shall be used.
5. Name of student along with student ID, class, section and name of school should be mentioned **on the backside only**. And No details of the students or school should be there in the painting/ drawing. Doing so may lead to disqualification.

6. The schools will organize a school level painting/ drawing competition for primary classes by last week of August 2024 and select three best entries. A certificate regarding completion of the competition and selection thereafter, should be taken from the Primary Incharge of the school on the letter head and the same should be forwarded by the HoS (with stamp) to Nursery Primary Branch during submission.
7. The schools will submit the selected three best entries in original form with covering letter & Certificate to Nursery Primary Branch in the **6th of September, 2024** at the Conference Hall (HQ) as per the schedule given below:

8. These entries will be reviewed at the Branch level by a Panel of judges and 100 best entries will be selected for the drawing/ painting competition among those who prepared them. However, all of the paintings received from schools will be displayed at the State Level Art Exhibition post scrutiny.

The complete schedule for the **State Level Art Exhibition cum Competition** will be declared in due course.
