

Guidelines/Expenditure Norms for organizing Nukad Natak & 10 Days survey of OoSCwSN under Gap Identification for OoSCwSN (Enrolment Drive) for 2022-23 at elementary level under Inclusive Education - Samagra Shiksha

General Guidelines:

1. The Zone-wise activities of Nukad Natak & 10 Days survey under Gap Identification for OoSCwSN shall be completed before 6th February 2023.
2. The 02 activities under Gap Identification for OoSCWSN intervention (Enrolment Drive) i.e. 02 Nukkad Natak per zone & 10 days survey of OoSCwSN shall be conducted by District Coordinators (IEB) and Zonal Coordinators (IEB) under supervision of DPOs/DDE (Districts).
3. Printed pamphlets shall be provided by IE-Branch (HQ), Lajpat Nagar-IV.
4. To maximize outcome of door to door survey and identifying suitable spots for organizing Nukkad Natak in particular area and maximize participation of local population as spectator of Nukkad Natak the survey team shall interact & collaborate with Resident Welfare Association (RWA) of target area.
5. District Coordinators (IEB) shall explore NGOs working with CwDs of designated cluster/district concerned, if available and agreed to collaborate on voluntarily basis for the activities under this intervention.
6. School Management Committee members may also be involved to bridge and connect with the local public and facilitate smooth implementation of activities related to enrolment drive.
7. On the spot queries/information regarding CwDs sought by local public attending Nukkad Natak/Rally shall be catered to & relevant information/guidance shall be provided to them by the District-team along with name and contact number of concerned person/authorities.
8. Whilst organizing outdoor activities where involvement of CWSN and their peers becomes intrinsic, NOC in advance shall be obtained from parents of students who will participate in such activities.
9. The authorized amount shall be fully utilized for the sole purpose of organizing Gap Identification for OoSCWSN Interventions. During incurring expenditure all the codal formalities shall be observed.
10. District Coordinator (IEB) shall submit report of activities of Nukkad Natak & 10 days survey of OOSCwSN within one week of its completion along with 20 photographs to Inclusive Education Branch, Lajpat Nagar-IV.



NUKKAD NATAK PROGRAM

1. 02 Nukkad Natak shall be conducted in each zone by District Coordinators (IEB) and Zonal Coordinators (IEB) along with PGT-SETs, TGT-SETs & Resource Person (CWSN).
2. Details regarding the Nukkad Natak program (i.e. venue and date) shall be finalized by DDE (District) and the same shall be informed to the Inclusive Education Branch, Lajpat Nagar-IV, in advance.
3. The banner for the said programme must include "Gap Identification for Out of School CWSN under Inclusive Education- Samagra Shiksha 2022-23 along with logo of scheme- Samagra Shiksha.
4. Play cards shall be used bearing catchy slogans informing public about admission procedure and different services provided by DoE for CwDs
5. Recorded jingles in audio-form may be played during Nukkad Natak performance/Rally through audio aids.
6. The Street Play (Nukkad Natak) shall be performed/presented in the neighborhood of school wherever the likelihood of having out of school CWSN is high.
7. The DDEs (District) shall ensure that all the preparatory arrangements for organizing Nukad Natak are made well in advance.

10 DAYS SURVEY of OoSCwSN

1. 10 Days survey under Enrolment Drive for 2022-23 shall be organized by formulating a team of 03 members including TGT-SET (Regular/Guest)/RP (CWSN) & CRCC-01 each- per survey team. Out of 03 members- 01 shall be CRCC: 02 shall be TGT-SET (Regular or Guest) and RP (CWSN) 01 each OR 02 TGT-SET (Regular or Guest), wherever RP (CWSN) is not available. One CRCC in each team shall be nominated by DURCC and the list of the same shall be submitted to concerned District Coordinator-IE.
2. To ensure the admission of the out of school/dropout CWSN in the regular govt. schools the survey team shall conduct a comprehensive door-to-door survey in the neighborhood to identify never enrolled or drop-out CWSN.
3. The emphasis is on mainstreaming out-of-school CWSN through diverse strategies, as far as possible, and on providing schooling for all children upto 18 years of age group. The primary objectives of the survey are.
 - To identify the Out-of-School CWSN upto 18 years of age
 - To identify the dropout children upto 18 years of age who left school After completing class I, II, III VIII
 - To enroll the Out of School CWSN in appropriate class, by filling learning gap, in the neighborhood school as per RTE Act. In case of students with severe and profound disabilities, who are unable to go to schools, enroll them for Home Based Education.



4. The report proforma to be filled for conducting 10 days survey of OOSCWSN is placed at **Annexure-II**.
5. After the completion of the activity, the survey team shall submit the survey records to the DPO through concerned District Coordinator (IEB). Further, concerned DPO shall submit a comprehensive summary of the survey to the Inclusive Education Branch (HQ), Lajpat Nagar-IV latest by 06.02.2023.
