Sub.: Re-engagement/Re-deployment of Guest Teachers working in the Govt. Schools/ Govt. Aided Schools/Taken Over Schools under Directorate of Education, Delhi for the academic Session 2024-2025.

Whereas the services of Guest Teachers working in the Govt. Schools/Govt. Aided Schools/Taken over Schools of Directorate of Education, Govt. of NCT of Delhi, were discontinued vide this office order No.DE.18.2(73)/E-V/2021/1514-21 dated 11.05.2024, as the summer vacations were declared w.e.f. 11.05.2024 to 30.06.2024, by the School Branch Dte. of Education, vide circular No.DE.41/Nur.Pry.Br./Annual School Calendar/2024/71 dated 08.05.2024.

Now, all the Guest Teachers who have been working in the Govt. Schools/Govt. Aided Schools/Taken over Schools of DoE, till 10.05.2024 are hereby directed to report to the HOS concerned on the date of re-opening of Schools, i.e. on 01.07.2024 without fail. In case a Guest Teacher fails to report to the School within 03 working days, it will be presumed that she/he is no longer interested for engagement and alternative arrangement will be made by this office.

However, this will not apply in case of Guest Teacher who have been disengaged due to misconduct/misbehavior/remained absent without prior permission of the HoS/ poor performance or resigned/long absent etc.

All the HoSs of Govt. Schools/Govt.Aided Schools/Taken Over Schools of Directorate of Education, are hereby directed to issue online experience certificate for the all such session of 2023-2024 (i.e. for the period w.e.f. 01.07.2023 to 30.06.2024) in the School w.e.f. of Guest Teachers who have been relieved/disengaged during the session or who have been working in the School w.e.f. 01.07.2023 to 30.06.2024. All the HoSs are also directed been working in the School w.e.f. 01.07.2023 to 30.06.2024. All the HoSs are also directed to update the online attendance of all the engaged as well as relived Guest Teachers in their schools so that the attendance of the Guest Teachers can be used for calculation of the working experience/days.

Further, such Guest Teachers who have been relieved due to joining of regular teacher/implementation of new PFC, during summer vacation i.e. between 11.05.2024 to 30.06.2024, they may also be allowed to join online and may be relieved immediately, with retrospective effect i.e. the date of joining of regular teacher. In case of any Guest

Teacher who has proceeded for maternity leave during summer vacation, she may be allowed joining online and may not be relieved till completion of her maternity leave, a brief explanatory proposal with this regard may also be furnished to this office for payment of salary in case of non-availability of vacant post, if any in the particular school.

This issues with the prior approval of the Competent Authority.
