ANNEXURE- I

Guidelines for Organization of Competition (Sports) for CWSN studying in schools that comes under Samagra Shiksha for the year 2022-23 at UT and District Level under Quality Interventions

1. Disability specific sporting events for persons with disabilities shall be organized first at District Level and the winners will further participate in competitions organized at HQ / State level and the winners and participants shall be felicitated with Awards/Prizes/Certificates.
2. **General Instructions** to be observed for Organization of Competition (Sports) for CWSN studying in schools that comes under Samagra Shiksha for the year 2022-23 at UT and District Level under Quality Intervention:
 - i. *District Level Competition (Sports) for CWSN shall be organized in 12 Districts of DoE, Delhi for students with disabilities studying in I to Class XII in schools that come under Samagra Shiksha latest by 20th March 2023.*
 - ii. *DPO/DDE (District) shall ensure that all suitable preparatory arrangements at the venue, so that the students with disabilities don't face any difficulties at the venue.*
 - iii. *Further, it may also be ensured that the expenditure should not exceed the allotted fund by Competent Authority.*
 - iv. *The district level sports activities shall be organized at the 04 identified venues in collaboration with Sports Branch GNCTD.*
 - v. *The concerned district shall ensure that resources/infrastructure available at the venue.*
 - vi. *Adequate staff may be deployed to ensure proper discipline and smooth functioning of the programme.*
 - vii. *District Coordinators (IE) shall submit report of celebration of Sports Activities/ Competition for CWD/CWSN along with the details of prize winners to this office within one week of its completion.*
 - viii. *Safety and security of students shall be accorded highest priority.*
 - ix. *District Coordinators (IE) shall submit the details of the programme along with 05 to 10 photographs.*
