And whereas, a Memorandum letter dated 26.07.2023 for Offer of Appointment was issued to above said candidate and during the due course of documents verification, it was noticed that said candidate does not possess essential qualification as per notified Recruitment Rules for the said post i.e. TGT (Maths) Male under post code 38/21 and deficiency memo was also issued to him.

Com (H) in 2011 without Maths, however he has studied Mathematics course as an additional subject in B.A Part-II in 2016 and in B.A Part-III in 2018. Similar kind of cases in other post code/subject post where candidates have studied the concerned/main subject as an Additional subject, have already been cancelled and rejected the candidature by this Directorate. And reference to OA No. 1029 of 2023 in the matter of K.M. Anita Vs Govt. of NCT of Delhi & Ors, Standing Counsel , GNCTD (Services) recommended to file appeal citing that " Bachelor's Degree in a subject that is studied by way of an additional subject is not adequate in as much as evidently a Bachelor's Degree in a subject taken as an additional subject would lack the width and depth of study that would be necessary to qualify as a Trained Graduate Teacher in that subject. In the sense that if the candidate lacks in-depth knowledge of a subject, he/she would hardly be qualified to teach it as a Trained Graduate Teacher ". Hence, his case is not recommended, for appointment to the post of TGT (Maths).
