ORDER

Subject: Re-Engagement of Upper Primary Teachers and Primary Teachers presently working under Samagra Shiksha-Delhi on contractual basis during the year 2024-25.

Samagra Shiksha-Delhi-Delhi has been engaging Subject-specific Upper Primary Teachers and Primary Teachers on contractual basis as a temporary measure to address the issue of Pupil Teacher Ratio (PTR) in Govt. Schools. The contractual period of Upper Primary Teachers and Primary Teachers that were engaged for the year 2024-25, was extended upto 31.03.2025 vide Order No. F.DE (29) UEEM/Access/13-24/Pt. File-I/982-989 dated 01.07.2024 of this office. Similarly the contract period of Primary Teachers that were engaged for the year 2024-25 in MCD Schools, was also extended upto 31.03.2025 vide same Order.

Accordingly, the Competent Authority is pleased to re-engage total 248 Upper Primary Teachers (presently working in DoE and SOSE School) and 151 Primary Teachers (in MCD Schools on diverted capacity) and 2099 Primary Teachers in MCD Schools on contractual basis by following the guidelines as stated below:

- The contract teachers shall be re-engaged preferably in the same schools, subject to the requirement on the basis of enrolment of the school. In case of non requirement in the same school, the contract teachers shall be posted in another school within the same district.
- 2. The contract teachers, against whom there is a case of indulging in dereliction of duty, may not be considered for re-engagement. However, the approval of concerned DPO has to be taken in every such case keeping in view the facts & circumstances.
- 3. The teachers, who absented from their duties in unauthorized way, without submitting leave application to HoS/DPO and have adverse report pending against them, shall not be considered for re-engagement in the year 2025-26,.
- 4. The re-engaged teachers shall not be asked to resubmit their original attested photocopies of documents as a routine. The original and/or attested photocopies or required documents shall be called from only those teachers whose documents are not available with the District. However, reason for the same have to be recorded by the competent officer of District.



5. The payment towards remuneration to the Upper Primary Teachers and Primary Teachers, re-engaged in DoE Schools or/and MCD Schools, shall be made strictly as per the approval contained in the Minutes of Meeting of the Project Approval Board 2025-26 of the Ministry of Education, Govt. of India.

In view of above, all the DPOs/DDEs are hereby directed to take fresh Agreement by issuing Offer Letter to all the contractual Upper Primary Teachers and Primary Teachers whose contract expired on 31.03.2025. The term of contract on reengagement would be from 02.04.2025 to 10.05.2025 or till commencement of summer break, whichever is earlier on the same terms and condition of previous agreement
