And whereas, during document verification, it was found that candidate has applied and selected in SC (GCT) category and a deficiency memo vide dated 04.05.2023 was issued to the candidate and asked to submit clarification /requisite/deficient documents.

2. Experience certificate of teaching at the time of cut-off date.

And whereas as per advertisement no. 02/21 by the DSSSB it was specifically mentioned that candidates who wish to be considered against reserved vacancies and/ or to seek age relaxation must be in possession of relevant certificates (EWS/SC/ST/OBC/Non Creamy layer/PWD/ Education Experience etc.)issued by the competent /notified authority (in prescribed format) or before the cut off date(closing date of advertisement) otherwise their claim for any category will not be entertained and their application will be considered against Un-reserved vacancies, if eligible otherwise.

And whereas the candidate is not fulfilling the eligibility criteria for the post of TGT (Hindi) Male as he is not working at the time of applying and has not submitted the requisite documents resulted which he is overage and not fit for consideration for appointment.
