CANCELLATION OF CANDIDATURE IN R/O SH. RAJESH GUPTA FOR THE POST OF TGT(HINDI) MALE POST CODE-34/21

Whereas, Sh. Rajesh Gupta, D.O.B. 05.03.1986, Roll No. 112703400457 under OBC (GCT) category was provisionally nominated & selected by the DSSSB for further processing for appointment to the post of TGT HINDI (Male) post code 34/21 in Directorate of Education, Govt. of NCT of Delhi and he was called for document verification vide this Office memorandum no.: F.NO. DE.3(28)/DRC/E-III/TGT/HINDI/MALE/2022/5044 dated 13.10.2022.

Whereas, in response to this, the said candidate reported at scheduled date & time of DV and accepted the offer of appointment.

And whereas, during document verification, it was found that Sh. Rajesh Gupta has applied and selected in OBC (GCT) category and a deficiency memo vide dated 04.05.2023 was issued to the candidate and asked to submit clarification /requisite/deficient documents.

1. Experience Certificate for all Academic year counter signed by DDE.

2. Experience certificate of teaching at the time of cut-off date.

And whereas the Sh. Rajesh Gupta is not fulfilling the eligibility criteria for the post of TGT (Hindi) Male as he was not working at the time of applying i.e. 04.07.2021 and has not submitted the requisite documents resulted which he is overage and not fit for consideration for appointment.

And whereas as per advertisement no. 02/21 by the DSSSB it was specifically mentioned that "candidates who wish to be considered against reserved vacancies and/ or to seek age relaxation must be in possession of relevant certificates (EWS/SC/ST/OBC/Non Creamy layer/PWD/ Education Experience etc.)issued by the competent /notified authority (in prescribed format) or before the cut off date(closing date of advertisement) otherwise their claim for any category will not be entertained and their application will be considered against Un-reserved vacancies, if eligible otherwise."

And whereas, with the approval of Chief Secretary (Delhi), a committee was also constituted consisting of senior officers of Govt. of Delhi to streamline the procedural aspects regarding EWS candidates and the committee after examined the issue raised in the matter unanimously agreed to abide by the instructions/OMs issued by DoPT, Govt. of India and recommended that the EWS/NCL Certificates issued/ submitted beyond crucial/cut-off date may not be entertained.

Keeping in view of the above facts & circumstances, the offer of appointment issued to him is hereby withdrawn and the candidature of Sh. Rajesh Gupta, D.O.B. 05.03.1986, Roll No. 112703400457 under OBC (GCT) category stand cancelled accordingly with retrospective date of offer of appointment.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by the department, in future."

This issues with the prior approval of the Competent Authority.
