<u>ORDER</u>

CANCELLATION OF CANDIDATURE IN R/O SH. RAJPAL SINGH YADAV FOR THE POST OF TGT(HINDI) MALE POST CODE-34/21

Whereas, Sh. Rajpal Singh Yadav, D.O.B. 27.02.1988, Roll No. 111403400092 under OBC category was provisionally nominated & selected by the DSSSB for further processing for appointment to the post of TGT HINDI (Male) post code 34/21 in Directorate of Education, Govt. of NCT of Delhi and he was called for document verification vide this Office memorandum no.: F.NO. DE.3(28)/DRC/E-III/TGT/ HINDI/MALE/2022/4980 dated 13.10.2022.

Whereas, in response to this, the said candidate reported at scheduled date & time of DV and accepted the offer of appointment.

And whereas, during document verification, it was found that a court case is pending against Sh. Rajpal Singh Yadav and accordingly, a deficiency memo vide dated 18.10.2022 was issued to the candidate and asked to submit clarification /requisite/deficient documents.

- 2. True copy of pending court case along with current status is required.

And whereas in response to the deficiency memo, Sh. Rajpal Singh Yadav informed that a case FIR No. 106/2021 registered in PS Maurice Nagar under Section 376 (2) (n) IPC is pending against him in the court of Sh. Ankit Singhla, Ld. ASJ (FTSC), Central District, Tis Hazari Court, Delhi.

Keeping in view of the above facts & circumstances, the offer of appointment issued to Sh. Rajpal Singh Yadav to the post of TGT Hindi (Male), under post code- 34/21 in Level 7 Pay Matrix (Pre-revised Pay Band-9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules, is hereby withdrawn and the candidature of Sh. Rajpal Singh Yadav, D.O.B. 27.02.1988, Roll No. 111403400092 under OBC categroy stands cancelled accordingly with retrospective date of offer of appointment.
