**CANCELLATION ORDER**

Whereas, vide Vacancy Notice Advertisement No.02/21 dated 12.05.2021, the DSSSB advertised the vacancies for the post of TGT (Natural Science) – Male under Post Code 35/21.

And whereas, reference to the aforesaid vacancy notice, Mr. Sachin Kumar Singh (D.O.B. – 25.11.1994) s/o Mr. Pramod Singh, Roll No. 111603500008, a candidate of 'EWS -PH: Ortho (OH) (One Leg)' Category was nominated by the DSSSB for the post of TGT (Natural Science) – Male, Post Code of 35/21 by the Selection Mechanism Authority i.e. DSSSB vide their Result Notice No 145 dated 28.07.2022 and his e- dossier was forwarded for further proceedings of Appointment.

And whereas, after the preliminary scrutiny of documents available in e- dossier, a Memorandum towards 'Offer of Appointment' was issued on 13.12.2022 to the aforesaid candidate with the directions to appear in person on the scheduled Date, Time and Venue alongwith all the requisite documents for Document Verification.

And whereas, it was observed during the course of documents verification conducted on 19.12.2022 by the assigned Team that the aforesaid candidate does not possess following requisite documents: -

1. B. ED Degree is required.
2. EWS Certificate required before cutoff date.
3. Father's name in PH certificate is mismatch.

And whereas, in this regard an opportunity was given to Mr. Sachin Kumar Singh by issuing a Deficiency Memo dated 19.12.2022 in which he was asked to submit clarification/requisite/deficient documents within 15 days. In response to aforesaid Deficiency Memo, above candidate submitted a computerized copy of "Disability Certificate" and undertaking to submit copy of B. Ed. Degree within 6-months and both submissions were accepted by the concerned Team. Further, two subsequent reminders on 07.05.2024 and 16.05.2024 were also issued to Mr. Sachin Kumar Singh towards submission of deficient documents i.e. Copy of B. Ed. Degree & valid EWS certificate as on cutoff date. In response to the deficiency memo dated 07.05.2024 and 16.05.2024, Mr. Sachin Kumar Singh informed vide his registered email dated 05.06.2024 that "he has been selected for two posts. i.e. TGT (Maths) - Male and TGT (Natural Science) - Male and is interested in joining for the post of TGT (Maths) - Male. He, further requested to cancel his candidature for the post of TGT (Natural Science) – Male. Presently, he has joined his duties as TGT (Maths) – Male in DOE.

And whereas, in view of the above facts and circumstances, the acts on the part of the aforesaid candidate is taken as willfully refusal to accept the OOA and it is concluded that the candidate is not interested in the appointment to the post of TGT (Natural Science) - Male, post code 35/21.

Keeping in view of the above facts and circumstances and since the candidate has willfully chosen not to be appointed for the nominated post, therefore, the Memorandum: Offer of Appointment dated 13.12.2022 issued in favour of Mr. Sachin Kumar Singh (D.O.B. 25.11.1994), Roll No. 111603500008, a candidate of 'EWS - PH/OH category is hereby withdrawn for the post of TGT (Natural Science) – Male under post code 35/21' and his candidature/nomination Stands Cancelled/Rejected accordingly with retrospective date of 'Offer of Appointment'.

*"No claim for Appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the Department, in future. "*
