CANCELLATION ORDER

Whereas, vide Vacancy Notice Advertisement **No.02/21 dated 12.05.2021**, the DSSSB advertised the vacancies for the post of TGT (Natural Science) – Male under Post Code 35/21.

And whereas, reference to aforesaid vacancy notice, Mr. **Narendra Singh** (DOB - 28.03.1980) s/o Mr. Diggpal Singh, Roll No. 111603500503, a candidate of 'EWS-PH-VISUAL(VH)(LOW VISION)' category was provisionally nominated by the DSSSB for the post of TGT (Natural Science) - Male under the Post Code of **35/21** by the Selection Mechanism Authority i.e. DSSSB vide their Result Notice No 145 dated 28.07.2022 and his e- dossier was forwarded for further proceedings of Appointment.

And whereas, after the preliminary scrutiny of documents available in e- dossier, a Memorandum towards 'Offer of Appointment' was issued on 13.12.2022 to the aforesaid candidate with the directions to appear in person on the scheduled Date, Time and Venue alongwith all the requisite documents for Document Verification.

And whereas, it was observed during the course of documents verification conducted on 19.12.2022 by the assigned Team that the aforesaid candidate does not possess following requisite documents: -

1. Candidate has produced documents regarding B. Ed. (Spl. Education), hence marksheet and degree for B. Ed. is required.
2. NCTE Certificate not Available.
3. EWS Certificate before cutoff date.

And whereas, in this regard an opportunity was given to Sh. Narendra Singh by issuing a Deficiency Memo dated 19.12.2022 in which he was asked to submit clarification/requisite/deficient documents within 15 days. In response to aforesaid Deficiency Memo, abovesaid candidate submitted an application cum representation dated 23.12.2022 alongwith various documents in support to remove aforesaid deficiencies whereby he replied for raised deficits and stated reg. deficit no.1 & 2 that he is a holder of B. Ed. (Spl. Edn.) Degree and having Rehabilitation Council of India's "Registration Certificate" as per RCI Act, 1992 instead of NCTE. He further quoted various references of various courts like order dated 16.09.2009 of Hon'ble High Court of Delhi in W.P. (C) No.6771/2008, Judgements dated 16.08.2022 of Hon'ble CAT in the cases – O. A. No. **2183/2015**, titled "**Uma Rani Vs. GNCTD through Chief Secy. & Ors.**" and judgement dated 31.03.2016 in O.A. No.3442/2014 (read with OA No. 2183/2015), titled "Shruti Poddar & Ors. Vs. KVS & Ors.". It is conveyed that aforesaid order dated 16.09.2009 is not relevant, however, other court cases are relevant in the instant matter. Further, conveyed that a case number W.P. (C) No.**700/2023** & CM APPL. 2729/2023, CM APPL. 64908/2023, titled "GNCTD & Ors. Vs. Ms. Uma Rani & Anr." (with other cases) has been filed in Hon'ble High Court of Delhi against judgement dated 16.08.2022 in O.A. No. 2183/2015 and Hon'ble High Court has granted stay against abovesaid judgement dated 16.08.2022 and case is still pending in Hon'ble CAT. The candidate further stated reg. deficit no.3 that he has been selected against reservation for visually impaired candidate, therefore, he can not be denied for appoint against the reserved vacancies for PWD category and this submission is acceptable.




And whereas, an opinion of Mrs. Avnish Ahlawat, Standing Counsel of the Department in Delhi High Court (as well as advice of L.A. of the Department) is available in a similar case of another post code in respect of a candidate - Ms. Renu Bala, Roll no. 111905500191 who provisionally nominated by the DSSSB for the post of TGT Sanskrit (Female), post code 55/21 having Degree of B.Ed. (Spl Edn.) instead of B. Ed. which as **"Since the qualification B.Ed. Special Education is not equivalent to B.Ed., the candidate cannot be appointed to the post of TGT Sanskrit and her candidature has to be rejected"**. Accordingly, thereafter, the candidature of Ms. Renu Bala had been cancelled on 25.08.2023 by the Department.

And whereas, as per Recruitment Rules, "The candidate should have degree/diploma in teaching". Since the qualification B.Ed. (Special Education) is not equivalent to B.Ed., Mr. Narendra Singh cannot be appointed to the post of TGT (Natural Science) - Male.

Keeping in view of the above facts & circumstances, it is clear that the aforesaid candidate is not eligible to be appointed for the post of TGT (Natural Science) – Male, Post Code 35/21, therefore, the candidature/nomination of Mr. Narendra Singh (Roll No 111603500503), a candidate of "EWS-PH-VISUAL(VH)(LOW VISION)" category is hereby **withdrawn/rejected** accordingly with retrospective date of 'Offer of Appointment' as the aforesaid candidate does not fulfil the required eligibility criteria according to the RRs/ para number 5(ii) & 8(viii) of vacancy notice advertisement no. 02/21 dated 12.05.2021 & relevant existing guidelines/ instructions issued by GOI/ Govt. of NCT of Delhi. However, this cancellation is **subject to final outcome of the decision** of the Hon'ble High Court of Delhi in case number W.P. (C) No. **700/2023** & CM APPL. 2729/2023, CM APPL. 64908/2023, titled "GNCTD & Ors. Vs. Ms. Uma Rani & Anr." (read with O.A. No. 2183/2015) and appropriate action will be taken in the matter accordingly, if any.
