ORDER

Cancellation of Offer of Appointment to the post of PGT (Computer Science)-Female , Post Code 30/22

Whereas, **Ms. NISHA JHA, D.O.B. 10/01/1993, Roll No. 121203000345** was nominated by DSSSB under waiting panel list in EWS category for the post of PGT (Computer Science)- Female against Post Code- 30/22 vide letter No.4(45)/DSSSB/CC-IV/2021/208-214 dated 12-04-2023 vide Result Notice No. 181 dated 12-04-2023 and accordingly the candidate was called for document verification vide Memorandum no. F.No. DE-2(97)/DRC/E-II/PGT (CS)/Female/2023/324 dated 07-06-2024 on dated 21.06.2024. After document verification the candidate vide Deficiency Memorandum no. F.No. DE-2(97)/DRC/E-II/PGT (CS)/Female/2023/435 dated 05.07.2024 was directed to submit requisite documents. As the candidate failed to respond to the said deficiency Memorandum and Subsequently Reminder-I deficiency memo no. 525 dated 08.08.2024 and Reminder-II deficiency memo no. 590 dated 29.08.2024 were issued. The candidate did not reply in response to the aforesaid deficiency memorandums.

Whereas, Final Reminder (last opportunity) to submit the requisite documents/clarification vide No. F.No. DE-2(97)/DRC/E-II/PGT (CS)/Female/2023/642 dated: 19/09/2024 was issued to the said candidate.

Whereas, it is found that the candidate has neither replied nor submitted any requisite documents/clarification till date.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Now, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Ms. NISHA JHA, D.O.B. 10/01/1993, Roll No. 121203000345** for the Post of PGT (Computer Science)- Female, Post Code 30/22 and return her dossier to the DSSSB.

This issues with the prior approval of the Director (Education).
