Consequent upon his/her selection through Delhi Subordinate Services Selection Board to the post of Librarian and with the Prior approval of the Competent Authority, the following candidate is hereby appointed purely on provisional basis to the post of Librarian vide post code 92/20 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to terms and conditions given in the offer of appointment and accepted by him/her. In the case of candidates who are referred to Govt. Hospital for medical examination and his/her medical fitness certificate is awaited, the Provisional Appointment is hereby given in relaxation of FR 10 and drawal of pay and allowances for a period not exceeding 2 months is subject to medical examination within 2 months from the date of Provisional Appointment and if the candidate(s) is/are subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him/her of the findings of the medical officer/board, if no appeal for second medical examination is made by him/her during this period or after the case for second medical examinations finally decided, if, such an appeal is made and accepted. In case of OBC/EWS candidate at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "It is hereby undertaken that the information furnished by me is true and correct and the OBC/EWS certificate is as per provisions contained in DSSSB advertisement number 04/20 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature / appointment is liable to be cancelled / terminated automatically without any notice and action can be taken against me by the department as per Rules'. Subsequently, the OBC/EWS verification report will be checked by the DDE concerned. If the OBC/EWS certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate is hereby directed to report to his/her respective place of posting latest by 29/12/2023 failing which his/her appointment shall be stand cancelled without any further communication.
