ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT(HINDI) MALE POST CODE-34/21

Whereas Sh. Vishnu Panchal (Employee ID – 20240411), D.O.B. 23.07.1989, Roll No. 111203400112 under UR category has been nominated by the DSSSB for the post of TGT (Hindi) Male under the post code of 34/21 vide letter No. F.No.4(612)/DSSSB/CC-I/2021/447-454 dated 28.05.2024 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Supplementary Result Notice No. 21 dated 28.05.2024 and after completion of further course of document verification on the scheduled date and time given in offer of appointment letter and medical examination thereafter. Accordingly, the said candidate was provisionally appointed under provisions of FR-10 and appointment letter was issued.

And whereas, as per Appointment Order issued vide no. DE.3(28)/DRC(E-III)/TGT(Hindi)/Male/2022/18 dated 20.06.2024, Sh. Vishnu Panchal (Employee ID - 20240411) was required to join the place of posting by the given date, but he did not respond. In continuation of appointment letter, final opportunity letter was issued to the said candidate vide no. DE.3(28)/DRC(E-III)/TGT(Hindi)/Male/2022/143-144 dated 25.11.2024 in the public domain with the direction to join the duty within stipulated time mentioned in the final opportunity. The joining time has already been expired and candidate failed to join despite of given ample time.

And whereas, neither Sh. Vishnu Panchal joined the duty/present physically before the Competent Authority nor any written request/representation for extension of joining time was received by this office i.e. Directorate of Education, GNCTD. Hence, it is concluded that the above said candidate is not interested to join the duty.

As per DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, the following has been mentioned.

“An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/department but extension beyond 3 months should not be granted liberally.”

And whereas, the Hon'ble C.A.T. in C.P. No. 734/2023 in O.A. No. 2473/2022 titled “Pradeep Kumar Vs. Sh. Naresh Kumar & Ors., GNCTD” has directed to dispose of the matter in the time bound manner.

In view of the above facts & circumstances, as stated above and since the candidate has willfully chosen not to respond to the memorandum, this tantamount to refusal to accept offer of appointment. Therefore, the candidature in r/o Sh. Vishnu Panchal (Employee ID – 20240411), D.O.B. 23.07.1989, Roll No. 111203400112 under UR category is hereby cancelled.

“No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by the department, in future.”
