## **ORDER**

Sub: - Withdrawal of Order dated 30.05.2024 reg. Termination of Services in r/o Mr. Hitesh Joon, issued under the proviso to sub rule (1) of Rule (5) of the Central Civil Services (Temporary Service) Rules, 1965.

Whereas, Mr. Hitesh Joon (Emp. Id. 20230358), Roll No. 112803500448 was terminated under the proviso to sub rule (1) of Rule (5) of the Central Civil Services (Temporary Service) Rules, 1965 vide Order No.F. DE.3(29)(1)/DRC/E-III/TGT/N. Sc./(M)/2022/4404-12 dated 30/05/2024.

Whereas, aggrieved with the Termination Order dated 30.05.2024, Mr. Hitesh Joon (Emp. Id. 20230358) approached the Hon'ble CAT vide O.A. No. 2433/2024 in the matter of "Hitesh Joon versus GNCTD & Ors.".

Whereas, Hon'ble CAT vide its Judgement dated **08.12.2025** in **O.A. No. 2433/2024** has directed as under: -

- 8. Accordingly, the present OA is allowed with the following directions:
- (i) The impugned order dated 30.05.2024 is set aside.
- (ii) The applicant shall be entitled for all consequential benefits including reinstatement in service, arrears of back wages, continuity of service etc.
- (iii) The competent authority amongst the respondents shall comply with the aforesaid directions as expeditiously as possible and preferable within four weeks from the date of receipt of a certified copy of this order.
- 9. However, in the facts and circumstances, there shall be no order as to costs.

Whereas, the Hon'ble CAT has also allowed various OA(s) in similar matter vide 2340/2024, 2425/2024, 2499/2024 and 2434/2024 filed by Mr. Navneet Singh, Mr. Durgesh Kumar, rejected candidates of the same post code i.e. 35/21 and by other rejected candidates of other post codes. The Hon'ble High Court, Delhi has upheld the orders/directions of the Hon'ble CAT, by issuing the specific directions dated 02.04.2025 (read with Corrigendum dated 22.04.2025), 25.04.2025, 16.04.2025 & 23.04.2025 in the filed various W.P.(C). by the DOE vide 4112/2025, 5326/2025, 4809/2025 and 5166/2025 respectively, for providing appointment to the candidates whose EWS certificates were issued before the completion of the financial year 2020-21 and between 01/01/2021 to 31/03/2021.
