**CIRCULAR**

**Subject: Postponement of Elections for reconstitution of SMCs- Revised Schedule of Conduct of Elections for re-constitution of School Management Committees (SMCs) in Government and Government Aided Schools of Directorate of Education Issued-Reg.**

**Reference: Circular No.F.23(6)/DE/RTE/2011/80-86, dated 08.05.2025, issued from Right to Education Branch of Directorate of Education-Reg.**

This is with reference to the Circular cited above, vide which detailed instructions were issued for Conduct of Elections for re-constitution of School Management Committees (SMCs) in Government and Government Aided Schools of Directorate of Education.

Now in continuation of the **Circular No.F.23(6)/DE/RTE/2011/131-138, dated 07.07.2025 for holding SMC Elections**, it is informed that due to administrative reasons, the Competent Authority has decided to postpone the schedule for conduct of Elections for re-constitution of SMCs and the new revised schedule is issued to conduct Elections for re-constitution of SMCs, as given below:

- (a) Receiving of signed Acknowledgment part of Format 'A' by the teacher by **08.08.2025 (Friday)**.
- (b) Receiving of Nomination Forms in plain paper by **11.08.2025 (Monday)**. **Those, parents/guardians, who could not submit their Nomination Forms in plain paper earlier, can now submit their Nomination Forms.**
- (c) Scrutiny of Nomination Forms and preparation of List of Candidates in Format 'B' by **13.08.2025 (Wednesday)**.
- (d) Preparation of Voting Sheet in Format 'C' by **14.08.2025 (Thursday)**.
- (e) Date of Elections is **19.08.2025 (Tuesday)**, (08:00 AM to 11:00 AM for Morning Shift/General Shift) & (01:00 PM to 04:00 PM for Evening Shift)
- (f) Declaration of Results on **20.08.2025 (Wednesday)**.

Further, it is informed that an online link on MIS Module for nomination application by Social Workers, will again be available from **02.08.2025 (11:00 AM)** at the Directorate of Education website [www.edudel.nic.in](http://www.edudel.nic.in) on its homepage. Interested Social Workers, willing to render pro bono service for the betterment of their neighborhood school, may apply at that link to be considered for nomination. The link shall remain open till **11:59 PM of 11.08.2025**.


Those, Social Workers and parent members, who have already applied vide **Circular No.F.23(6)/DE/RTE/2011/60-67, dated 24.04.2025** and **Circular No. F.23(6)/DE/RTE/2011/134-138, dated 07.07.2025**, need not to apply again. However, such Social Workers, who could not submit their application earlier, may apply fresh. Only one application of any Social Worker will be accepted.

Based on the recommendation of the **Permanent Core Group** from amongst the online applicants, the concerned DDE (District) should appoint the Social Worker for all schools under their jurisdiction latest by **14.08.2025**. The list of the school wise appointed Social Workers will be provided to Heads of Schools by the DDE (Districts) on or before **18.08.2025** positively.

The Heads of Schools would ensure that the online entry of the new SMC is made on [www.edudel.nic.in](http://www.edudel.nic.in) within a week of the declaration of the results.

All other instructions and guidelines issued vide **Circular No. F.23(6)/DE/RTE/2011/60-67, dated 24.04.2025**, remain unchanged.
