Subject: Extension of Time-period for online application by Social Workers for inclusion in School Management Committees-Reg.

Reference: Circular No.F.23(6)/DE/RTE/2011/155-161, dated 01/08/2025, issued from Right to Education Branch, Directorate of Education. (Copy enclosed).

This is with reference to the Circular cited above, vide which detailed instructions were issued for inviting online applications from Social Workers for their appointment in School Management Committees (SMCs) in Government and Government Aided Schools of Directorate of Education, Delhi.

The present status of the ongoing process of reconstitution of SMCs has been reviewed comprehensively with all Deputy Directors of Education (District) at the level of Directorate of Education Delhi.

Considering the feedback received from various Deputy Directors of Education (District), about the number of online applications received from Social Workers for various schools, and requests received, for providing further opportunity for online application, from various Social Workers across various Districts, the Competent Authority has decided to open once again, link on MIS Module for nomination application by Social Workers, which will now be available from 18.08.2025 (11:00 AM) to 31.08.2025 (11:59 PM) at the Directorate of Education website www.edudel.nic.in on its homepage.

Those, Social Workers, who have already applied vide Circular No F.23(6)/DE/RTE/2011/60-67, dated 24.04.2025, Circular No. F.23(6)/DE/RTE/2011/131-138, dated 07.07.2025 and Circular No. F.23(6)/DE/RTE/2011/155-161, dated 01.08.2025, need not apply again. However, such Social Workers, who could not submit their application earlier may apply fresh.

It is further clarified that there will be no change in Date of Elections and Date of declaration of Results of SMCs.

The schedule for appointment of Social Workers at the level of Deputy Director of Education and providing the list of the school wise appointed Social Worker to Heads of Schools by the DDEs (District), will be intimated on completion of Elections to SMCs and declaration of Results of SMCs.

All other instructions and guidelines issued vide Circular No. F.23(6)/DE/RTE/2011/60-67, dated 24.04.2025 remain unchanged.
