The Sports Branch, Directorate of Education, Govt. of NCT Delhi is going to conduct Open selection trials cum Coaching Camp for 68th National School Games 2024-25 for Baseball (U-17y Boys & Girls) on 03rd April 2025 from 03:00 pm onwards at S Co-Ed Vidyalaya L-Block Hari Nagar, New Delhi-64.

The selected student/player will represent Delhi in 68th National School Games 2024-25 in Baseball (U-17 Boys & Girls) to be held at New Delhi, w.e.f. 22nd to 27th April 2025 under the aegis of SGFI.

Open selection trials shall be conducted for Baseball (U-17y Boys & Girls). All the participants should be in proper kit as per Baseball rules. The coaching camp of selected players will start from 04.04.2025 to 20.04.2025.

The player should be **born on or after 01/01/2008 for U-17y years age categories** and should be a student of up to 12th class or below but not below 6th Standard. The participating player must be a regular enrolled student of the Delhi schools under Directorate of Education.

The students who have passed 12th Standard will not be eligible to participate in the SGFI National School Games irrespective of being in any age category.

The students of Kendriya Vidyalaya are not eligible to participate in the selection trial.

All students/players are required to bring all original documents like Birth certificate, 10th class Certificate with DOB, Certificate of DOB from HOS/Principal, Aadhar Card, School I-Card etc. along with one set of photocopies (self-attested). All students/players are also required to bring completely filled Annexure-I (copy attached) during trials.
