The teacher will get a certificate regarding verification of all the educational qualification as per applicable RRs to the post of TGT/TGT(MIL) from concerned DDE (E-III), Directorate of Education, GNCTD, for relieving from his/her duty.

The concerned Municipal Authorities shall ensure that the teachers are relieved to assume the charge of promotional posts latest by **30/07/2025**, after ensuring that there is no vigilance case /departmental enquiry pending / no penalty in operation against the teachers at any level at the time of relieving to assume the charge of promotional post. It should be specifically/ clearly mentioned in the relieving order of the promoted teachers that no vigilance case is contemplated/ pending against his/her at any level.
