

Subject: Status of the KVPY and SHE program of DST-reg.

The "Kishore Vaigyanik Protsahan Yojana" (KVPY) program was incepted in 1999 by the Department of Science and Technology (DST), Ministry of Science and Technology, Government of India and implemented by IISc, Bengaluru to identify students with talent and aptitude for research; help them to realize their academic potentials, encourage them to take up research careers in science and ensure growth of best scientific minds for research and development in the country. KVPY Fellows are offered fellowship for a maximum period of five years at any educational institution in India, provided they pursue a graduation/postgraduation course in Basic Science areas. More than 5000 brightest students of the country were benefitted by this programme to pursue research and development career. KVPY Fellowship for the first three years (B.Sc. level) - Rs 5,000/- +Rs 20,000 Contingency grant. KVPY Fellowship for the 4th & 5th years (M.Sc. level) - Rs 7,000/- +Rs 28,000 Contingency grant.

Since Scholarship for Higher Education (SHE) component of INSPIRE Scheme was catering to the common mandate of KVPY, it was subsumed with the INSPIRE-SHE component to increase the scope for offering Scholarships to a greater number of talented/bright students aspiring their career in Science and Technology in 2022.

Scholarship for Higher Education (SHE) component of Innovation in Science Pursuit for Inspired Research (INSPIRE), provides scholarship to the meritorious students to study basic and natural sciences in B.Sc. and M.Sc. Around 12,000 (11,000 Direct Mode + 1000 Institutional Mode) scholarships are given every year. Under the Direct Mode, students within top 1% cut-off marks at the Class XII Board (State or Central) examinations and pursuing science courses at undergraduate/ Integrated MSc or MS program are eligible for INSPIRE Scholarship. Under the Institute Mode, applicants receive their Scholarship for taking up undergraduate/integrated post-graduate degree courses in basic and natural sciences in various IITs, IISERs, NISERs etc. Selections are based on performance (top 1%) in Class XII examinations of State/Central School Examination Boards and/or selected in national level competitive examinations like IIT-JEE within top 10,000 rank, NEET within top 10,000 rank, National Talent Search Examination (NTSE) Scholars, International Olympiad Medallists, IISERs and NISERs National Level Admission Test etc. The Scholarship amount @ Rs 0.80 lakh per year (Rs. 5,000/- per month + Rs. 20,000 Annual Mentorship Grant) for a duration of 5 years.
