Special Cases of State Teacher's Award 2025

The State Teachers Awards (Special Cases) was instituted with the primary objective to recognize and honour those (Principals, Vice Principals and Teachers) who, through their extra ordinary commitment and exemplary efforts, have contributed to improve the quality of Education in Delhi.

In this regard, the contribution of the members of the teaching fraternity, who are working in different Branches at Head Quarters, is not less important. Such Principals, Vice Principals & Teachers (who are working in some Branch of HQs) are not required to fill up the routine online Proforma for State Teacher's Awards. They may apply for the State Teachers Awards 2025 (Special Categories) by filling the offline Proformas attached herewith for their respective categories.

The guidelines & procedure to be followed for applying for State Teachers' Award-2025 in Special Categories are as under:

PROHIBITIONS:

- 1. The teachers/Principals/Vice Principals who have already received the State Teachers' Award in any category are not eligible.
- 2. In the case of HOSs who have received Excellence in Education Award in any category during last three years (i.e. 2021-22, 2022-23 & 2023-2024) are not eligible.

GUIDELINES:

- 1. Detailed Eligibility criteria are separately attached with all the concerned Special Category proformas.
- 2. Each desirous applicant for State Teachers' Awards in Special Category must apply offline in the prescribed pro forma meant for their specific category only.
- 3. No correction will be allowed after the submission of the filled in Proforma. Therefore, in case of any query, please contact the concerned Branch/Award Branch for clarification (before submission of the application) as mentioned below:

PROCEDURE FOR FILLING UP THE PROFORMA

- 1. The applicants must read the Circular/Guidelines carefully before filling in the Proforma.
- 2. The applicants must apply only in one category i.e. in any one of the Proformas A to G.
 - Forms of the candidates applying for more than one category shall be summarily rejected.
- 3. All the applications must be submitted in the prescribed Proforma only. Applicants must not try to make any changes in the Proforma. Applications received in changed/altered proforma shall be summarily rejected.
- 4. The applicants must submit two Passport size photographs.



- 5. Vigilance Clearance Reports of School Level, District Level, HQs Level must be attached with documents, in original.
 - In case of Vice Principals/Principals, Vigilance Clearance from Directorate of Vigilance, GNCTD is also required.
- 6. The candidates must note that merely making a claim fetches No Marks. Marks/weightage will be given only on attachment of proof e.g. certificates/documents/photographs etc. duly authenticated by next higher authority, as desired in the concerned Proformas.
- 7. Therefore, all teachers must submit the supporting documents and proofs point-wise in support of each claim made by them in the Application. These proofs may include relevant supporting material such as Certificates by HOS (in case of teachers), Certificates by DDE Zone/DDE of the Concerned Branch (in case of Principal/Vice Principal), documents, tools, reports of activities, field visits, online links accessed for academic growth, copies of articles published in reputed Journals, relevant initial pages of books written & printed, attested copies of results and photographs of the activities conducted etc.
- 8. Applicants must also attach a Brief Write Up About their 'Achievements in the Field of Education'.
- 10. The applicants must furnish a Certificate duly signed by next higher authority (after the verification of record) to the effect that the applicant has never received State Teachers' Award earlier and Excellence in Education Award during last three years (for Vice- Principals/ Principals). This Certificate, in original, must be countersigned by the DDE District and attached with the offline application proforma.
- 11. The applicant must sign a Certificate at the end of the Proforma to the effect that all the information furnished by him/her in the Application & Supporting Documents is correct. Any wrong/false information given by the applicant will attract disqualification as well as disciplinary proceedings.

PROCEDURE FOR SUBMISSION OF FILLED PROFORMA

- 1. All desirous teachers/Principals/Vice Principals in Special Category shall submit filled proforma along with photographs and self attested copies of supporting documents and certificates in hard copy with the HoSs concerend as per the Time line prescribed.
- 2. Applicants must not wait for the Last Date to submit the Proforma. They should submit it along with all required documents as early as possible.

The HOS must ensure that all the columns in the Proforma are duly filled in, by the applicant teacher. The information filled-in should be verified from record e.g. teacher's diary, inspection report, exam register, SMC register, annual result of the school and the service book of the applicant etc. The HoS must satisfy herself/himself fully about the veracity of claims made by applicant, wrt. Results, Seminars attended, books/articles published, efforts made to improve attendance, check dropout rate and other innovations claimed to have been introduced in pedagogy.

The HOS will stamp & countersign each & every page of the application and the annexures after a thorough verification of all the supporting documents from school records.

Given the urgency of the matter and limited time available, the HoSs must give Top Priority to thorough scrutiny of the applications and the annexed documents for onward submission to the office of DDE Zone strictly as per the Timeline given in this circular.

It may be noted that the applicant & the HoS shall be jointly responsible for the accuracy of claims made in the Proforma.

- 3. After verification, the Hos shall forward the complete file to DDE Zone concerned strictly in line with the Timeline.
- 4. The DDE (Zone) must personally ensure that every page & every column of the proforma is duly verified, countersigned and certified by the HOS of concerned school with his/her stamp & signature.
- 5. After personally checking all the proformas and the supporting documents provided, the DDE (Zone) will forward all the applications/ nominations of Spl. Category of HOSs/teachers, to DDE (District) concerned.
- 6. In case of HoS/Principal/Vice Principal, each page of the application & self-attested photocopies of supporting documents will be verified and countersigned by the DDE (Zone) (with stamp) alongwith supporting documents, photographs etc. The file, thus complete, will be forwarded to DDE (District) after complete satisfaction of DDE Zone w.r.t. veracity & accuracy of the information provided.
- 7. Further, the DDE District, after his/her complete satisfaction wrt. all the required documents and the veracity of facts, will forward only those applications of Principals/vice Principals/Teachers to the concerned branches, which are clear from Vigilance angle at HQs & Distt levels.
- 8. Please note that in the cases of Vice Principals & Principals, the Vigilance Clearance Report of Distt. Level, GOC (H.Q.) Level and DOV Level issued for the purpose of State Teachers Award 2025, is mandatory. Vigilance Clearance Certificates with expired validity won't be accepted.
- 9. All the applications for Award (refer Proforma A to F) except Proforma G are to be forwarded by District DDEs to the Branches concerned (as mentioned in the column no. IV of the Table above) strictly in accordance with the Timeline provided.
- 10. The Guest Teachers & Contract Teachers under Samgra Shiksha working in the Directorate of Education, GNCTD shall submit the filled Proforma concerned (G) alongwith self-attested photocopies of supporting documents/certificates with their respective HOS.

As in all other categories, the HoS shall scrutinize and verify each & every page on the basis of record and forward the same to DDE Zone who will, in turn, forward the file to DDE District.

In case of (Guest Teachers& Contract Teachers Under Samagra Shiksha working in the Directorate of Education), the DDE Districts shall forward the same to the Samagra Siksha Branch and the Samagra Siksha Branch will scrutinize all documents and award marks strictly as per the rubric and thus recommend the selected candidates to Awards Branch strictly as per time line prescribed.

Tease note that Vigilance Clearance as such is not a requirement for the Guest Teacher & Contract Teachers under Samagra Shiksha. For more details, please do consult the specific guidelines for this category.

PROCEDURE FOR SELECTION

1. The DDEs of concerned HQ branches will constitute a committee to evaluate and scrutinize the nominations/ applications (of Special Category received from Distt. DDEs) according to the Marking Scheme.

The constitution of the Committee is as under:

A. Addl. DE of the concerned Branch -Chairperson -Member

C. OSD/ State Co-ordinator/Equivalent Officer -Member

D. District Co-ordinator/ Equivalent Officer -Member

E. Any other Officer but not below the rank of Principal -Member

Important: While evaluating the applications, the Committee must appreciate the difference b/w routine activities & extraordinary achievements. Marks should be awarded in recognition of the extraordinary achievements which contributed significantly towards upliftment of the standard of learning and Not to 'Routine Activities' performed by the applicants.

2. The minimum benchmark for recommendation of Special Category candidates is 60%. No application below 60% should be recommended by these committees to the Awards Branch at HQs.






