

Whereas, in the case of Mrs. Anandita Singh, on verification of her service record, it has been found that the retrospective probation extension orders issued earlier were not warranted in light of the factual position now duly established on the basis of verification report. It has been concluded that the retrospective extension of probation previously issued in her case was not in consonance with the factual position now duly verified. Accordingly, the said retrospective probation extension orders are hereby withdrawn ab initio.

And whereas, after review of the previous orders, it has been decided that probation extension orders issued retrospectively in her case cannot be sustained in law. Accordingly, such retrospective probation extension orders are also hereby withdrawn ab initio.

Now, therefore, this office has come to the conclusion that in purview of RRs and significant verification report simultaneously, the retrospective probation extension orders issued in respect of the aforesaid candidate stand withdrawn ab initio, and shall be treated as null and void, without prejudice to their service rights .
