## **CIRCULAR**

Subject- Extension of Timeline for registration of Students for CET-2025 (JEE/NEET/CLAT/CA/CUET), MVPP & NMMSS Exams.

Online registration of students for appearing in CET-2025 under Mahamana Pt. Madan Mohan Malaviya Vidya Shakti Mission, MVPP Exam & NMMSS Exams was commenced vide circular No. DE.44(1)/Edn./SB/2025/1212-1216, F. No. DE. 40(13)/Sc.Br/MVPP/2025/554-561 & F.No. DE.40(13)/Sc.Br/NMMSS/2025/549-553, Dated:10/09/2025 & . The last date for registration for CET-2025 was 30/09/2025 & last date for MVPP & NMMS Exam was 04/10/2025.

Science Branch has received many mails from the Head of the Schools for extension of the timeline for registration of students on the portal. It has been reported that due to ongoing Mid-Term Examination the Head of the Schools need more time for registering the students on the portal. Considering the request of the Head of the Schools, Competent Authority has extended the time line for registration of students upto 16/10/2025.

On account of considering the benefits of students, all the Heads of the Schools are directed to ensure registration of all the remaining eligible students for various Exams viz. CET-2025 (JEE/NEET/CLAT/CA/CUET) for only Govt. Schools, Mukhya Mantri Vigyan Pratibha Pariksha(MVPP) for Govt./Govt. Aided/Private Unaided/KVS/NVS/NDMC/DCB Schools & National-Means-Cum-Merit Scholarship(NMMS) for Govt. & Govt. Aided Schools on or before 16/10/2025. The Head of the Schools must note that no further request for extension of date of registration shall be entertained.

The DDE(Districts), DDE(Zones) & Head of the Schools are directed to ensure registration of all remaining eligible students for CET-2025, MVPP & NMMS Exams on or before 16/10/2025. This issues with the prior approval of the competent authority.
