**CANCELLATION OF CANDIDATURE IN R/O SH. BHEEM FOR THE POST OF TGT(HINDI) MALE
POST CODE-34/21**

Whereas SH. BHEEM, D.O.B. 18.04.1991, ROLL NO. 112703400477 under -EWS category has been nominated by the DSSSB for the post of TGT (Hindi) Male under the post code of 34/21 Vide letter No. F.No.4 (612)/DSSSB/CC-I/2021/1049-1055 dated 02.08.2022 (as per vacancy advertisement no.02/21) by the Selection Mechanism Authority i.e. DSSSB vide Supplementary result notice No 21 dated. 28.05.2024 and accordingly the offer of appointment was issued to the candidate vide this Directorate Memorandum dated 03.06.2024 and called for document verification on 07.06.2024.

And whereas, Sh. Bheem was issued a medical letter for appearing before the medical Board for conduction of medical examination. And subsequent reminders were issued when Sh. Bheem, Roll No. 112703400477 did not appear before the medical board of DDU Hospital, GNCTD.

And whereas, a final opportunity notice was issued vide dated 11.09.2025 with prior approval of the competent authority. Further, neither he has intimated any reason to the directorate for not reporting and nor he has appeared before the medical board.

Whereas the act on the part of the aforesaid candidate is taken as refusal to accept the OoA and it is concluded that the candidate is not interested in the appointment to the post of TGT Hindi (Male) , under post code- 34/21 in Level 7 Pay Matrix(Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules

Therefore, the Offer of Appointment issued Sh. Bheem (DOB: 18/04/1991), having Roll No. 112703400477 under-EWS, Post code 34/21, TGT Hindi (Male) is hereby withdrawn and his Candidature stands cancelled , accordingly. No further correspondence in this regard will be entertained by this department in future.
