SUB:- Guidelines for verification of documents & admission under EWS/DG Category students at entry level (i.e. Nursery/KG/Class-1st) in Private Un-aided Recognized School of Delhi under RTE Act, 2009 & DSEAR, 1973 by DoE, MCD & NDMC for the academic session 2025-26 selected through Computerized Draw of lots.`

In continuation of this Directorate's circular NO.F.DE.15 (258)/EWS/PSB/2025-26/30-38 dated 03.01.2025 (copy enclosed), following instructions are issued for all concerned for taking necessary action:

1. The Computerized draw of lots for Online Application received from EWS/DG Category students for admission at the Entry Level Classes (Nursery/Pre-School, KG/Pre-primary, Class-1) has been conducted on 05/03/2025 (Wednesday).

Guideline for candidates:-

1. The candidates who have been allotted schools in the computerized draw of lots (hereinafter referred to as **successful candidates**) shall be informed about the school allotted and address of location of verification of documents for admission (hereinafter referred to as **document verification centre**) under EWS/DG Category through SMS on their registered mobile number, within 24 hours of completion of draw of lots.

The list of such successful candidates shall be uploaded on the department website i.e. www.edudel.nic.in.

- a) The applicants can also check the name of the school allotted through Computerized Draw of lots using Registration ID & Date of Birth at the link 'EWS/DG Result 2025-26 in the module 'EWS/DG Admission 2025-26' available at the Home page of the departmental website www.edudel.nic.in.
- b)If the applicant has been allotted the school, the screen will show the allotted school name & address of Document Verification Centre.
- c) If the applicant has not been allotted any school, the screen will show a message as "It is regretted that you have not been selected in the draw of lots".

- d) If the applicant enters wrong Registration ID/Date of Birth then the screen will show a message as "No Record Found".
- 2. The successful candidates shall approach the Document Verification Centres to get their documents verified as per schedule mentioned at annexure A along with the following documents, as per the information filled in the online application form.
 - (1) Two Print out of the application filled
 - (2) Two photographs of the candidate.
 - (3) Two Copy of Aadhar Card of Child (Not mandatory).
 - (4) Two Copy of Aadhar Card of Parents.
 - (5) Two Self Attested photocopy of proof of date of birth
 - (6) Two Self Attested photocopy of Residential Proof.
 - (7)Two Self Attested photocopy of documentary proof for EWS/DG Category, whichever applicable.
 - (8) Two Self attested copy of legal guardianship (if applicable).

The parents/guardians shall also keep the original documents with themselves for verification by the sub-committee of the zone.

The details of the venue of the Document Verification Centre is mentioned in the Annexure-B

- 3. If the successful candidates fail to report to the Document Verification Centre as per the schedule mentioned in Annexure-A for verification of documents for admission under EWS/DG, the candidature for admission under EWS/DG will be cancelled.
- 4. The school once allotted to the applicant through the computerized draw of lots shall not be changed under any circumstances.
- 5. The allotment of school of the child shall be cancelled in case the documents submitted by the successful candidates at the time of verification of documents are found to be forged/fake or not supportive at any stage.

Guideline for Sub-Committee/Zonal Authority.

- 1. The following procedure to be adopted for documents verification of successful candidates:
- a) The Sub-Committee of the Zone will recommend the name of successful candidates whose documents are found in order for admission under EWS/DG category to respective allotted Private Unaided Recognized Schools by issuing an order. Recommended candidate has to be report to the allotted school for admission on or before 26 May 2025. If the recommended candidate didn't on or before report

- before the last date of admission, the candidature for admission under EWS/DG Category will be cancelled.
- b) Further, if any discrepancies are found in the documents provided by the successful candidates, deficiency memo will be issued to the candidate and they will be allowed to submit the valid/updated document for claiming bona-fide entitlement of admission under the category of EWS/DG on or before 11th April, 2025 (10:30 AM to 4:30 PM).
- c) Final opportunity to be given to the Not Reported successful candidates for scrutiny of documents for admission between 31th March to 05th April 2025 (10:30 AM to 4:30 PM).
- d) In the case of rejection of allotment of candidate, order shall be passed by DDE Zone based on recommendation of the sub-committee of the zone.
- e) If, parents are not satisfied with the order passed by the DDE Zone, the parents can file appeal to DAMC between 23rdApril -08thMay, 2025. DAMC will examine & pass final orders by 20th May.
- f) The Name & Id of the successful candidate through the computerized draw of lots will only be shown in the login Id of respective DDE zone on edudel. Further, recommended candidate shall be updated at edudel portal as 'admitted', rejected candidate as 'rejected' and not reported candidate shall be updated as 'Not reported' by the DDE Zone concerned.
- g) The sub committee will keep one set of photocopy of documents produced by the successful candidates during the verification of documents for the purpose of record keeping. One set of photocopy of document must be attached with the order regarding recommendation of the candidate for admission in allotted school for the purpose of record keeping in respective school of the admitted candidate

Instruction for Private Unaided School:-

- 1. The Private Unaided School have to update status as '**reported**' on the edudel portal of all the candidate who have been recommended by the sub-committee and reported to the school on or before the last date of admission i.e. 26/05/2025. If the recommended candidate didn't report on or before the last date of admission, the school can update the status as '**Not reported**'.
- 2. The school shall not charge tuition fee from the students admitted under EWS/DG Category. Further, schools have to provide the free books, school uniforms and

writing material to each and every student admitted under EWS/DG Category within one week from the date of candidate reporting to school as per the recommendation of sub-committee of the Zone.

- 3. Schools are advised to hold introduction session for all parents together including the parents of EWS/DG Category children
- 4. The order passed by the sub-committee of zone/ DAMC as applicable, shall be final and binding upon Private Unaided Recognized Schools to grant admission to the recommended candidate. The candidate will not be subjected to any further scrutiny apart from what was done by the subcommittee of the zone. If any school violates these guidelines, action, as deem fit, in accordance with the extant rules and provision of RTE Act 2009 & DSEAR Act, 1973 will be initiated against such schools.

General Instruction for all concerned:-

- 1. In case of any grievances regarding verification of documents and admission under EWS/DG, aggrieved parent can approach concerned Office of the Deputy Director of Education, District, Directorate of Education, Delhi where Nodal officers have been appointed for resolution. The details have been attached as **Annexure** 'C'.
- 2. In case of any grievance related to Private Unaided Recognized schools of MCD, aggrieved parents can approach concerned Education Department of Municipal Corporation Delhi where Nodal officers for their respective zones have been appointed. The details have been attached as **Annexure** 'D'.
- 3. In case of any grievance related to Private Unaided Recognized schools of NDMC, all aggrieved parents can approach concerned Education Department of New Delhi Municipal Corporation where Nodal officers have been appointed. The details have been attached as **Annexure** 'E'.
- 4. For any clarification /grievances in any context, parents/school may contact respective Dy. Director of Education (District/Zone). All District (DDE/Zone)/Assistant Director are requested to ensure that above said instruction are adhered to strictly during the verification of documents. All DDE (District/Zone) of DOE/MCD/NDMC will setup a Help Desk to facilitate and redress grievances of Parents of EWS/DG Category.
- 5. For any clarification /grievances in this context parents may contact on the EWS helpline number 9818154069 on working days from Monday to Friday between 10 am to 5PM.

- 6. Further, all Dy. Director of Education (District/Zones) / Assistant Director of NDMC & MCD shall attend the EWS/DG parents sympathetically and resolve their grievances timely.
- 7. Allotment through the computerized draw of lots for admission under the EWS/DG category for the session 2025-26 in Private Unaided Recognized Schools, Delhi is subject to the outcome of order/judgement in the case number W.P. (C) 2646/2025, W.P. (C) 2623/2025 and W.P. (C) 2701/2025.

CIRCULAR

Sub: Guidelines for admission under EWS/DG and Children with Disabilities Category as defined in the Right of Persons with Disability (RPWD) Act, 2016 at Entry Level Classes (Pre-school/Nursery, Pre-primary/KG and Primary/Class-1) in Private Unaided Recognized Schools (except Minority Schools) of Delhi for the academic session 2025-2026.

- 1. As per Section 12(1)(c) of RTE Act, 2009, all Private Unaided Recognized Schools (except Minority Schools) are under obligation to admit at least 25% of strength at the entry level (Pre-School/Nursery, Pre-primary/KG&Primary/Class-1) class(es) by children belonging to Economically Weaker Section, Disadvantaged group and CWSN in neighborhood and provide free and compulsory education till completion of elementary education.
- 2. Directorate of Education is facilitating admissions of Economically Weaker Sections/Disadvantaged Group Category and Children with Disabilities Category in Private Unaided Recognized Schools under Delhi School Education Act & Rules, 1973 and RTE Act, 2009, at the entry level classes (Pre-school/Nursery, Pre-primary/KG and Primary/Class-1) for academic session 2025-2026 through COMPUTERIZED ONLINE ADMISSION SYSTEM. The applicant may access the Directorate's Website i.e. www.edudel.nic.in and click on "EWS/DG Admission" link available on home page for applying.

3. Admission under -

- (1) EWS Category- (A child whose parents have total annual income of less than 5 lakh rupees from all sources /BPL/AAY & who have been staying in Delhi).
- (2). DG category- (SC/ST/OBC-Non-creamy layer/Orphan/Transgender and the children living with HIV) shall be made through computerized lottery system in Private Unaided Recognized Schools (except Minority schools) for 22% seats (EWS/DG) under the Provisions of Right to Education Act, 2009 read with notification No. F.19/DDE(IEDSS)/Admi.Cell/PSB/2018/26923 dated 23.07.2018.
- (3). In accordance with notification No. F.19/DDE(IEDSS)/Admi.Cel/PSB/2018/ 26923 dated 23.07.2018, 3% seats will be for Children with Disability (CWSN- Children with Special Needs) within the 25% seat reserved.
- 4. The Directorate of Education, GNCTD started the process of online allotment of seats in EWS/DG/CWSN category by computerized draw of lots at the entry level of class(es) in the Private Unaided Recognized schools (except

Minority Schools) recognized under DSEAR, 1973 w.e.f. year 2016-17, and from year 2018-19 it was further extended in Private Unaided Recognized schools (except Minority Schools) recognized under RTE Act, 2009.

- 5. The Private Unaided Schools recognized/provisionally recognized up to Primary level (Vth Class) by MCD and NDMC, have been included in the Computerized Online Admission System for EWS/DG/CWSN category admissions at entry level as per Section 12(1)(c) of RTE Act, 2009 for which a separate circular/order may be issued by the MCD and NDMC. Directorate of Education is only making arrangement for Online Computerized Draw of Lots for the Private Un-aided Schools under MCD and NDMC. The grievances regarding admission/seats of EWS/DG/CWSN category students will be dealt by MCD and NDMC at their own level.
- 6. Only a single registration can be done by using one Mobile Number. All communication related to application/admission process will be made only through that phone number.
 - 7. Only a single application shall be filed for a child by an applicant for online admission process. Multiple applications filed for a child shall lead to cancellation of candidature of the child, even after succeeding in the draw of lots for admission. Also, in accordance to circular dated 04.10.2023 issued by Director (Education), it is mandatory to submit Aadhaar No. of Parents/Legal Guardian for applying for the admission at entry level under EWS/DG/CWSN in Private Unaided Recognized Schools of Delhi to avoid duplicacy of applications. However, the Aadhaar No. of child is not mandatory for applying online for admission under EWS/DG/CWSN category.
- 8. A child can avail only one-time benefit for admission at entry level under EWS/DG/CWSN category in Private Unaided Recognized Schools (except Minority schools) vide order No DE. 15(1025)/PSB/2023/Pt file/7706-7711 dated 01.09.23. A child already admitted under EWS/DG/CWSN category cannot apply again for admission under EWS/DG/CWSN category in Private Unaided Recognized Schools.
- 9. The schedule for the said online admission process is as follows:

The detailed Mechanism for admission under EWS/DG/CWSN Category can be found on Public Circular No. F.DE.15(258)/EWS/PSB/2025-26/14-19 dated 02/01/2025 at official website of DoE, GNCTD i.e. www.edudel.nic.in. Further schedule of scrutiny of documents and admission shall be notified after the computerized draw of lots.

10. Any person residing in Delhi, having the residence proof of Delhi and requisite Income Certificate issued by the Revenue Department of GNCT of Delhi, BPL/AAY(Ration Card/ Food Security Card Holder) are eligible for applying in these Private Unaided Recognized Schools for admission of their ward under Economically Weaker Section Category.

11. Economic Weaker Section (EWS)/DG/CWSN

(a) Economic Weaker Section (EWS)

"Income certificate (total annual income of less than 5 lakh rupees from all sources) must be issued by the Revenue Department of GNCT of Delhi". Date of Issue of Income certificate or application/Receipt for issue of income certificate must be before the last date of applying for online admission process. BPL/AAY(Ration Card/ Food Security Card Holder) issued from GNCT of Delhi are eligible under Economic Weaker Section for applying in these Private Unaided Recognized Schools for admission of their ward under Economically Weaker Section Category.

(b) Disadvantage Group (DG) category: -

Schedule Caste, Schedule Tribe, Other Backward Class (Non-creamy layer). Orphans, Transgender and all children living with or affected by HIV, shall be considered as Disadva ntaged Group Category as defined in Section 2 (d) of the RTE Act, 2009. Schedule Caste, Schedule Tribe, Other Backward Class (Non- creamy Layers) must have certificate issued by Revenue department of GNCT of Delhi. A valid Non-creamy layer certificate must be required along with Other Backward Class Certificate for availing benefit under Other Backward Disadvantaged Group Category as defined in Section 2 (d) of the RTE Act, 2009. Schedule Caste, Schedule Tribe, Other Backward Class (Non- creamy Layers) must have certificate issued by Revenue department of GNCT of Delhi. A valid Non-creamy layer certificate must be required along with Other Class (Non-creamy Layers). Orphans (Notification No.F.15(172)/DE/ACT/2010/4926-40 dated 17.10.2012, Transgender (Notification dated 09.10.2014) and all children living with or affected by HIV (Notification dated 06.07.2017) shall be included in DG category. Income certificate is not required to claim the benefit of DG Category.

(c) Children with Special Needs:-

The applicant under Children with Disability Category must have disability certificate issued by Govt. Hospital as mentioned in assessment, guidelines issued under RPWD Act, 2016. The certificate of disability issued under the persons with disabilities (equal opportunities, protection or rights and full participation) Act, 1995 (of 1996) shall continue to be valid after

commencement of the act for the period specified therein. Income certificate is also not required to the applicant under Children with Disability Category.

12. Regarding Age Limit: -The eligible age limits for admission in the entry level classes (Pre-school/Nursery, Pre- primary/KG and Primary/Class-1) for EWS/DG category will be the same as it was in the previous year i.e.

Age criteria for Children with Special Needs: -The Child with Disabilities Category have disability certificate issued from a Government Hospital as mentioned in assessment guidelines issued under RPWD Act, 2016. The certificate of disability issued under the persons with disabilities (Equal opportunities, protection or rights and full participation) Act, 1995(1 of 1996) shall continue to be valid after commencement of the act for the of the continuation therein. In period specified 11.09.2017 dated Cell/2017-18/2609-2613 265/DDE(IEDSS)/Admn (Person with benchmark disability' as a person with not less than forty percent of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority") and F.213/DDE(IEB)/Admn. Cell/2022/6417-6431 dated 09.08.2023. The age criteria for Children with Disabilities Category is as under: -

13. Regarding prohibition of demand of Capitation Fee/Donation at the time of admission.

Capitation fee means any kind of donation or contribution or payment other than the fee notified by the school" As per the order of Hon'ble High Court in LPA 196/2004 in the matter of Rakesh Goyal vs. Mont Fort School and section 13(1) of RTE Act, 2009 no school or person shall, while admitting a child, collect any Capitation fee. Donation from the parents. Any school or

person who contravenes this provision and receive Capitation fee shall be punishable fine which may extent to 10 times the Capitation charged.

14. Residential address is main criteria for allotment of seat through computerized draw However, it has been observed that Parents/Guardian manipulate by opting wrong Locality/Sub-Locality/Sub-Sub-Locality deliberately in order to get admission in a preferred school Therefore, necessary amendment/changes have been done in online registration form in respect of filling details regarding Residential Address (i.e., Locality/Sub-Locality/Sub-Locality), which is as under: -

If it is found at any stage that wrong information regarding residential address of a child is filled in order to get admission in a preferred school, then application of the child will be liable for cancellation.

- 15. The allotment of the child shall be cancelled in case the documents submitted by the applicant at time of scrutiny of Documents or later stage is found to be forged/fake. Allotment of child shall be cancelled if variation is found in details filled in online application and documents submitted at time of scrutiny of Documents. There is no provision for change in data submitted by Parents/Legal guardian at the time of application, so request for change cannot be considered.
- 16. Multiple/Duplicate entries/applications, if found at any stage, shall be liable to cancellation of candidature /admission of the candidate. The school once allotted to the applicant through the computerized draw of lots shall not be changed under any circumstances.
- 17. A monitoring Cell & helpdesk shall be constituted in each district under the chairmanship of the Deputy Director of Education (Districts) to redress the queries and grievances pertaining to online application of EWS/DG/Children with disabilities category admission and to ensure admission of successful candidates selected through computerized draw of lots in accordance with instructions and guidelines issued by DOE.
- In addition to the above, for any grievance relating to admission process in EWS/DG &Children with Disabilities category in the Private Unaided Recognized Schools of DoE complaints or queries may be raised at helpline number 9818154069 (between 10.00 AM to 5.00PM on all working days (Monday to Friday).
- 19. The mechanism for redressal of the queries and grievances pertaining to the admission process in the Private Unaided Schools Recognized of MCD and NDMC will be dealt by MCD and NDMC separately.

All the above directions are issued for strict compliance by all concerned and non-compliance of the order shall be viewed seriously.
