ORDER

On the recommendations of the Review Departmental Promotion Committee, the Competent Authority is pleased to order the promotion of 07 **Assistant Teachers (Primary)** and 01 **Assistant Teacher (Nursery)** working in MCD/DOE to the post of TGT/TGT (MIL) in the pay scale of Rs.9300-34800 +Grade pay Rs.4600/- (Pre-revised) plus usual allowances as admissible under the rules, on regular basis.

The promotion shall be subject to the following conditions:-

- (i) The promotion is further subject to vigilance clearance in terms of DoPT OM No.22011/4/91-Estt.(A) dated 14.9.92, OM No. 22012/1/99-Estt. (D) dated 25.10.2004 and OM No. 22034/4/2012-Estt. (D) dated 2.11.2012. In case of pendency of such proceedings, the matter may be reported to E - III Branch, DOE immediately.
- (ii) The promotion is subject to the condition that the teachers fulfill all the requirements as laid down in the RRs of TGT/TGT (MIL) post of this Directorate.
- (iii) The promotion is effective from the date of assumption of charge of the post of TGT/TGT (MIL) by the teacher concerned in the Department, in pursuance of this order. Monetary benefits of the promotion will accrue from the date of joining to the post of TGT/TGT (MIL) in this Directorate, pursuant to this order.

Date of promotion in r/o **SI. no.01, 03 and 04** (mentioned in above table), may be treated with effect from the date of promotion of his/her immediate junior promoted to the post of TGT/TGT (MIL) vide Directorate's order no 01 & 02 dated 11.04.2025.

Also, promotion of **Anita Nashier**, Assistant Teacher Primary, (SI no. 146), **Seema Kapoor**, Assistant Teacher Primary, (249), and **Krishna Kumari**, Assistant Teacher Nursery, (SI no. 03), who were promoted earlier, vide order no.02 dated 11.04.2025, is hereby cancelled with retrospective effect.

The promotion is subject to the condition that the teachers fulfill all the requirements as laid down in the Recruitment Rules of TGT/TGT (MIL) of this Directorate and is further subject to the condition that there is no vigilance case/departmental enquiry pending or no penalty is in operation against the teacher concerned at any level.

If the teacher does not accept the promotion, no offer of promotion will be provided to him/her for a period of one year from the date of refusal or till the next vacancy occurs, whichever is later. If the reasons given by the teacher for his/her refusal for promotion are not acceptable to the Appointing Authority, then this Department may enforce the promotion of the teacher and in case the teacher still refuses to accept the promotion, disciplinary action can be taken against her for refusal. Teachers refusing promotion and debarred consequently will lose their seniority, if promoted later.

The concerned Municipal Corporation authorities are requested to direct these promoted teachers for submission of their willingness to join the promotional post and verification of relevant documents for which schedule will be declared in due course by concerned District (DOE). Further, the DDEs (Districts) are directed to obtain fresh vigilance clearance of above teachers, before relieving/joining them to assume their promotional post. It shall be the responsibility of the DDE concerned to ensure that all documents in original are checked and found as per Recruitment Rules before allowing the joining to concerned teacher. Eligibility certificate as per RRs along with status of vigilance clearance report in respect of the teachers are to be sent to this office. Any lapse in this regard will be viewed seriously. Any clarification on this matter may be referred to E-III branch, DoE, before issuing relieving orders. In case of teachers found ineligible for promotion as per RRs or not having vigilance clearance, their promotion order will be cancelled.

This is issued with the prior approval of the Competent Authority.
