ORDER

Sub: Withdrawal of Cancellation order bearing no. DE.3(31)/DRC(E-III)/TGT(maths)Female/2022/3119 dated 12/03/2024 of Ms. Sujeeta, Roll No. 112803700292 and DOB: 05/07/1992.

Whereas, the candidature of Ms. Sujeeta , Roll No. 112803700292 was cancelled vide order bearing no. DE.3(31)/DRC(E-III)/TGT(maths)Female/2022/3119 dated 12/03/2024 in compliance to the U.O. note bearing no.F.19(07)/2020/S-IV/226 dated 05/02/2024 issued by the Dy. Secretary (Services), Services branch – IV, Services Department, GNCTD.

Whereas, the Hon'ble CAT O.A. No.533/2025 dated 05/08/2025 Ms.Sujeeta Vs. GNCTD & Ors has directed that:

"we quash and set aside the impugned deficiency memo dated 09.11.2022 and cancellation/rejection order dated 12.03.2024 issued by the R-3 - Directorate of Education. We direct Respondent no. 3-Directorate of Education, GNCTD to take on record the EWS certificates submitted by the applicant (who is otherwise meritorious) and if she is otherwise found suitable; consider appointing the applicant to the post of TGT (Maths) Female -Post Code 37/21. This exercise should be completed within a period of two months from the date of receipt of a certified copy of this order. Needless to mention, the applicant would be entitled to all notional benefits including seniority and fixation of pay and allowances. However, there will be no payment of any arrears on the principle of 'No work no pay."

Whereas, the Hon'ble CAT orders vide O.A.nos. 2434/2024 dated 14/01/2025, 2340/2024 dated 09/12/202, 2499/2024 dated 19/11/2024 and 2425/2024 dated 20/12/2024 and the Hon'ble High Court, Delhi has also upheld the orders/directions of the Hon'ble CAT in the W.P.C.nos. 4809/2024 dated 16/04/2025, 4112/2025 dated 02/04/2025, 5326/2025 dated 25/04/2025 and 5166/2025 dated 23/04/2025 for giving appointment to the candidates whose EWS certificates are issued before the completion of the financial year i.e. between 01/01/2021 to 31/03/2021.

Now with the approval of the Hon'ble Lt.Governor, Delhi, the cancellation of candidature order bearing no. DE.3(31)/DRC(E-III)/TGT(maths)Female/2022/3119 dated 12/03/2024 of Ms. Sujeeta Roll No. 112803700292 is hereby withdrawn in accordance with the Hon'ble CAT O.A. No.533/2025 dated 05/08/2025 Ms. Sujeeta Vs. GNCTD. She will be entitled to all notional benefits including seniority and fixation of pay and allowances. However, there will be no payment of any arrears on the principle of 'No work no pay."
