

4. School posting order dated 01/08/2025.
5. The Concerned Municipal Authority shall ensure that the teacher(s) is/are relieved to assume the charge of promotional post by 20/08/2025 after ensuring that there is no Vigilance Case/Departmental Enquiry pending/No Penalty in Operation against the teacher at any level at the time of relieving to assume the charge of Promotional Post.
6. It should be specifically/clearly mentioned in the relieving order of the Promoted Teachers that no Vigilance Case is contemplated/ pending against him/her at any level.
7. In case of any discrepancy the concerned MCD Authorities may contact to E-III Branch DoE GNCT of Delhi.


