CIRCULAR

SUB: Guidelines for the Activity "Twinning of Schools" for the financial year 2024-2025.

The Project Approval Board 2024-25 (PAB) of Ministry of Education, Govt. of India, for Samagra Shiksha-Delhi has approved the proposal of **Twinning of Schools- Cultural Exchange Activity at Elementary Level**. A sum of Rs. **36.29990 Lac only (Rs. Thirty Six Lakhs Twenty Nine Thousand Nine Hundred and Ninety Only)** has been approved and sanctioned by the Secretary (Education)/President, EC-Samagra Shiksha-Delhi.

All DPOs and DURCCs are directed to conduct activity "Twinning of Schools 2024-25 at cluster/school level" to provide healthy interaction and exposure to students.

The details of the activity are as under:

Activity: Twinning of Schools

Implementation Level: School/Cluster Level

No of Schools: 130 Schools

Target Group: Students of class 6th 7th and 8th.

Guidelines for Twinning of the Schools:

1. The amount is sanctioned to concerned DDEs/DPOs under Major Component "Funds for Quality (LEP, Innovation, Guidance etc)" for Twinning of Schools.
2. Each School(Venue School) is sanctioned amount of Rs. 27923/- (for three days activity)
3. Under this activity, in each district, there will be twinning of unaided/recognized Schools with neighbouring Government School.
4. 60 students will participate. (30 students from Govt. Schools and 30 students from Govt. unaided/recognized Schools for each class)
5. Activity on the theme **decided by the School** is to be conducted at Elementary Level i.e. for classes 6th 7th and 8th.
Activities to be performed at Venue School by Students:
 - i. Poster Making
 - ii. Cultural Dance
 - iii. Sports and games
6. The winners (1st 2nd and 3rd) will be selected from above mentioned each activities separately.
7. The activity should be conducted in the presence of CRCCs.
8. The activity is to be conducted within School hours.
9. Students of Guest school should reach at the venue (host school) at school timings before Assembly and stay at the host school till dispersal of the students.
10. The Twinning of the school programme will be organised for three days for students of class 6th 7th and 8th separately to experience the working and environment of the schools e.g. the venue school will invite the three separate guest schools for class 6th 7th and 8th.
11. The class teachers of the twinned class will participate in the activity.

12. The last two periods of the day shall be utilised for short cultural programme by the students of the host school for the students from the guest school.
13. The funds will be authorised as in advance to the host school and settlement of the advance should be done within two weeks from the date of completion of the activity. Funds sanctioned should be utilised for students of all four schools i.e. One host school and three guest schools.
14. DPO/DDE/DURCC districts will monitor the activity.
15. A brief report should be submitted to SS-HQ after completion of activity.


