Cancellation of Candidature for the post of TGT (Computer Science-39/22)

Mr. Gaurav Singh, Roll No. 131202301702 (Cat.-SC) has been nominated by the DSSSB for the post of TGT Computer Science under post code-39/22 and accordingly offer of appointment was issued to him vide order no. DE.4(81)/DRC/E-IV/TGT(CS)(39/22)/2024/3000 dated 30/05/2025.

Whereas, after successfully completion of scrutiny of documents, Mr. Gaurav Singh, Roll No.131202301702 (Cat.-SC) was called for document verification on dated 10/06/2025 at 11:00 AM at Conference Hall, DOE HQ, Old Sett., Delhi-54, failing which his offer of appointment shall stand cancelled without any further communication. However, the candidate was absent during document verification on aforesaid date.


Further, Mr. Gaurav Singh, was issued 1st and 2nd reminder on dated 11/06/2025 & 17/06/2025 respectively, to appear for Document Verification at DRC E-IV Branch. In response he has submitted vide email dated 18/06/2025, that he is employed in Central Government organization, so he is unwilling to join this post.

And, whereas the official concerned neither appeared for Documents Verification and nor willing to join the post of TGT Computer Science under post code 39/22.

Therefore, in view of the above facts and circumstances and, since the candidate has willfully chosen not to join this post, the provisional Offer of appointment order issued to Mr. Gaurav Singh, Roll No. 131202301702 (Cat.-SC) is hereby withdrawn and candidature stands cancelled.
