ORDER

Cancellation of Candidature for the post of Assistant Teacher (Primary)-42/21

Whereas, Mr. Pulkit Singh Rahal (Roll No: 121104205470, DOB: 06/08/1997, Selection Category: UR, Emp.Id: 20240953) was provisionally nominated by the DSSSB for the post of Assistant Teacher (Primary) under post code-42/21 and accordingly offer of appointment was issued to him vide Office Memorandum No. F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/17 dated 08/01/2024.

And whereas, appointment cum posting order vide posting ID 20240117 dated 22/11/24 was issued to the candidate with the direction to join his duties on his place of posting latest by 24/12/2024, but he failed to join his respective place of posting within stipulated time.

And whereas, the candidate was issued Final Opportunity vide letter no. F.DE.4(60)/DRC/E-IV/PART FILE/(42/21)/PRT/2023/Pt.-2/3010 dated 10.06.2025 to join the place of posting within 15 days.

And whereas, the candidate has still not joined for his duties on respective place of posting and no extension request has been received from the candidate till date to this office.

The above act on the part of the candidate is taken as refusal to join and it is presumed that the candidate is not interested in the appointment to the post of Assistant Teacher (Primary), under post code-42/21 in Level 7 Pay Matrix (Pre-revised Pay Scale - 9300-34800 with Grade Pay of Rs. 4200/-) plus usual allowances as admissible under the Rules.

Accordingly, the offer of appointment and provisional appointment order issued to Mr. Pulkit Singh Rahal vide Posting ID 20240117 is hereby withdrawn and the candidature stands cancelled. No further correspondence, in this regard, will be entertained by this department, in future.
