**Subject: Open selection trials cum Coaching Camp for 68<sup>th</sup> National School Games 2024-25 for Softball (U-14 y Boys & Girls) on 24 January 2025 from 02:00 pm onwards at Sports Complex F-Block, Vikaspuri, New Delhi.**

The Sports Branch, Directorate of Education, Govt. of NCT Delhi is going to conduct Open selection trials cum Coaching Camp for 68<sup>th</sup> National School Games 2024-25 for Softball (U-14 y Boys & Girls) on 24 January 2025 from 02:00 pm onwards at Sports Complex F-Block, Vikaspuri, New Delhi.

The selected student/player will be eligible to represent Delhi in 68<sup>th</sup> National School Games 2024-25 in Softball (U-14y Boys & Girls) to be held at Sambhajinagar, Maharashtra w.e.f. 13 to 16 February 2025 under the aegis of SGFI.

All the participants should be in proper kit as per Softball rules. The coaching camp of selected players will start from 25.01.2025.

The player should be born on or after 01/01/2011 for U-14 years age categories and should be a student of up to 12<sup>th</sup> class or below but not below 6<sup>th</sup> Standard. The participating player must be a regular enrolled student of the Delhi schools under Directorate of Education.

The students who have passed 12<sup>th</sup> Standard will not be eligible to participate in the SGFI National School Games irrespective of being in any age category.

The students of Kendriya Vidyalaya are not eligible to participate in the selection trial.

All students/players are required to bring all original documents like Birth certificate, 10<sup>th</sup> class Certificate with DOB, Certificate of DOB from HOS/Principal, Aadhar Card, School I-Card etc. along with one set of photocopies (self-attested). All students/players are also required to bring completely filled Annexure-I (copy attached) during trials.
