ORDER

Sub: Withdrawal of Cancellation order bearing no. DE.3(32)/DRC/E-III/TGT(Maths)/Male/2022/338-339 dated 06/03/2024 of Mr. Pawan Kumar, Roll No. 113903800672 and DOB: 16/11/1994.

Whereas, the candidature of Mr. Pawan Kumar, Roll No. 113903800672 was cancelled vide order bearing no. DE.3(32)/DRC/E-III/TGT(Maths)/Male/2022/338-339 dated 06/03/2024 in compliance to the U.O. note bearing no.F.19(07)/2020/S-IV/226 dated 05/02/2024 issued by the Dy. Secretary (Services), Services branch – IV, Services Department, GNCTD.

Whereas, the Hon'ble CAT O.A. No. 1659/2024 dated 19/11/2024 Mr. Pawan Kumar Vs. GNCTD and Others has directed that:

" the OA has merit and deserves to be allowed. We accordingly quash and set aside the impugned order no. DE.3(32)/DRC/E-III/TGT(Maths)/Male/2022/338-339 dated 06/03/2024 and direct the respondents to verify the admissibility of the Income & Asset Certificate issued by the Tehsildar, Salhawas..... The applicant would be entitled to all consequential benefits like seniority and promotion on notional basis. However, there will be no payment of arrears of pay and allowances."


Whereas, the Hon'ble CAT orders vide O.A. nos. 2434/2024 dated 14/01/2025, 2340/2024 dated 09/12/2024, 2499/2024 dated 19/11/2024, 1659/2024 dated 19/11/2024 and 2425/2024 dated 20/12/2024 and the Hon'ble High Court, Delhi has also upheld the orders/directions of the Hon'ble CAT in the W.P.C. nos. 4809/2024 dated 16/04/2025, 4112/2025 dated 02/04/2025, 5326/2025 dated 25/04/2025, 10080/2025 dated 17/07/2025 and 5166/2025 dated 23/04/2025 for giving appointment to the candidates whose EWS certificates are issued before the completion of the financial year i.e. between 01/01/2021 to 31/03/2021.

Now, therefore, with the approval of the Hon'ble Lt. Governor, Delhi, in accordance with the Hon'ble CAT O.A. No.1659/2024 dated 19/11/2024 of Mr. Pawan Kumar Vs. GNCTD and Others, cancellation of candidature in respect of Mr. Pawan Kumar, DoB – 16/11/1994, Roll No. 113903800672 for the post of TGT (Maths) Male, Post code 38/21, issued vide order bearing no. DE.3(32)/DRC/E-III/TGT(Maths)/Male/2022/338-339 dated 06/03/2024, is hereby **WITHDRAWN**. He will be entitled to all consequential benefits like seniority and promotion on notional basis. However, there will be no payment of arrears of pay and allowances.
