Further, all concerned HOS, Dte. Of Education, GNCTD are directed to ensure that the reporting Guest Teacher(s) is having the Experience Certificate of her/his working days and also possessing requisite qualification according to the prevailing notified RRs for the post, before allowing joining of their duties in the School.

Further, engagement of Guest Teachers is a stop gap arrangement and does not confer any right for permanent joining. The Guest teacher shall be relieved once a permanent teacher joins the school.
