Consequent upon selection through Delhi Subordinate Services Selection Board to the post of PGT (Political Science) - (Female), vide supplementary Result No. 1580 dated. 13.01.2026 and in compliance with the order dated 06.09.2023 of the Hon'ble Tribunal in OA No. 1422/2019, as upheld by the Hon'ble High Court of Delhi vide order dated 26.11.2025 in W.P. (C) No. 301/2024 in the matter of Yasmeen Vs. DSSSB & Ors., with the Prior approval of the Competent Authority, the candidate is hereby appointed on Provisional basis to the post of PGT (Political Science) - (Female) vide post code 150/2012 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4800 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her, In case of OBC/EWS candidate the appointment will be provisional at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "It is hereby undertaken that the information furnished by me is true and correct and the OBC/EWS certificate is as per provisions contained in DSSSB advertisement number 02/2012 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature / appointment is liable to be cancelled / terminated automatically without any notice and action can be taken against me by the department as per Rules". Subsequently, the OBC/EWS verification report will be checked by the DDE concerned. If the OBC/EWS certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate(s) is/are hereby directed to report to their respective place of posting latest by 30/08/2026, failing which his/her appointment shall stand cancelled without any further communication. 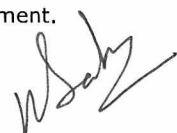
