ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (NATURAL SCIENCE) POST CODE-36/21

Whereas, the following candidates were nominated for the post of TGT (Natural Science) under the post code 36/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide supplementary result notice no. 256 & supplementary result notice no. 305 dated 05/11/2024 & dated 01/01/2026 respectively and their e-dossiers received from DSSSB for further proceedings of appointment **in compliance to the judgement order passed by the Hon'ble CAT in C.P No. 955/2024 in O.A No. 1410/2024.** For the appointment purpose, Offer of Appointment letters issued to all the below mentioned candidates to follow the due course of documents verification on the scheduled date & time given in the Offer of Appointment letter.

And whereas, despite repeated communications/reminder memorandums issued by the DoE in compliance to the judicial direction but the following candidates not reported/appeared on the scheduled date & time given in the Offer of Appointment letter. In this connection, final opportunity was also given to the all the below listed candidates with the direction to appear for further process of appointment. But they did not report despite of given sufficient opportunity.

And whereas, in view of the non-response and despite being given ample time to join the proceedings, the candidates have neither present physically nor any written request/representation received for taking any joining time extension in this office i.e. DoE, GNCTD, in this regard. Therefore, it is presumed that the above said candidates are no longer interested in joining to the said post and **it is evident that the candidates are not willing to avail benefit provided in compliance to the judgement order passed by the Hon'ble CAT in C.P No. 955/2024 in O.A No. 1410/2024.**

Now whereas, in accordance with the direction mentioned in the DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, says that "***An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time.***"

Therefore, in view of the forgoing facts & in light of the above said OM, the Candidature/provisional appointment letters issued to them are hereby withdrawn immediately and the Candidature of the aforesaid 05 (five) candidates stand cancelled, accordingly with the retrospective date of OoA.
