**ORDER**

**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (Punjabi) POST CODE-810/24**

**Sub: Proposal for candidature cancellation of the certain candidates who studied B.Ed (Special Education) instead of B.Ed. (General) in r/o TGT(Punjabi) F post code-810/24.**

**Whereas**, the following candidates nominated to the post of TGT (Punjabi) under the post code 810/24 vide Result No.131 dated 18/02/2026 and their e-dossiers have received from DSSSB for further proceedings of appointment. After the scrutiny of the received E-dossiers, certain deficit candidates in terms of essential qualification were kept on hold.

**And whereas**, during scrutiny of the E-dossiers and document uploaded/submitted by the selected candidates, it has been observed that the aforesaid candidate does not have proper qualification and it does not meet with the notified Recruitment Rules as per the vacancy advertisement for the said post as they possessed B.Ed.(Special Education) Degree. For taking necessary action in this regard, Deficiency Memo issued to the candidates for improper qualification with the direction to submitted the clarification and in response to the memorandum, the candidates have submitted the unsatisfactory without any significant documentary proof.

**And whereas**, upon receipt and documents submitted/furnished by the candidates against the memo issued to them, after examination of the records of the candidates, it has come to the notice that these candidates possessed **B.Ed. (Special Education) degree instead of B.Ed. (General)** which is the qualification contemplated under the Recruitment Rules for the post of TGTs. Accordingly, the candidature of the candidate was not considered eligible in view of the prescribed qualification.

**Essential qualification as per Vacancy advertisement & notified RRs for the post of TGT (Punjabi) under post 810/24.**

*"i. B.A. (Honours) in Punjabi or B.A. with Punjabi **as one of the elective subjects from a recognized University** having 45% marks in aggregate with one additional language or one school subject at degree level. As per RR of the said post code "The candidate should have studied the subject concerned as mentioned in the RR's for at least 02 years during the Graduation course. The elective word may also include main subject as practiced in different Universities"*

OR

Equivalent oriental degree in Punjabi from a recognized university having 45% marks in aggregate. Provided further that the requirement as to the minimum of 45% marks in the aggregate shall be Relaxable in the case of

- a. Candidates who possess a post Graduate Qualification in Punjabi from a recognized university.
- b. Candidates belonging to SC/ST.
- c. Physically handicapped candidates.

**ii. Degree in Education.**

iii. Knowledge of Hindi is essential.\*\*

iv. Should have qualified CTET from CBSE."

And whereas, in view of the above mentioned notified required qualification & in light of the Recruitment Rule set for the post and thorough examination of furnished accorded educational qualification documents, wherein essential qualification mandates that candidates must have possessed B.Ed. (General) whereas A Bachelor of Education (B.Ed.) in Special Education is a 2-year undergraduate program designed to train educators to support students with disabilities (e.g., Intellectual Disability, Visual Impairment, Hearing Impairment, Learning Disability). It is approved by the Rehabilitation Council of India (RCI) and it does not meet the essential qualification that prescribed for the post of TGTs and any deviation in this regard is not permissible under extant rule.

Therefore, in view of the facts stated above & the in light of the set RRs for the post, the candidature of the above mentioned candidates are hereby withdrawn being not in conformity with the stipulated rule for the post or do not meet the essential qualification for the said post and their candidature stand cancelled, accordingly without any further correspondence.

**"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."**
