**ORDER**

**Cancellation Of Candidature For The Post Of TGT (Punjabi) F Post Code-810/24**

**Whereas**, the following candidates were nominated for the post of TGT (Punjabi) under the post code 810/24 (as per vacancy advertisement no. 02/24) by the Selection Mechanism Authority i.e. DSSSB vide Result No.131 dated 18/02/2026 (revised result) and their e-dossiers received from DSSSB for further proceedings of appointment. After completion of further course of documents verification on the scheduled date & time given in the Offer of Appointment letter and Medical Examination thereafter, the said candidates were provisionally appointed on purely temporary basis and appointment letter were issued to them thereof (Details mentioned in the list below).

**And whereas**, as per appointment order, the candidates were required to join their place of posting by the given date, but they did not reported. In continuation of appointment letter, final opportunity letter & reminder letters were repeatedly issued to the said candidates through post and also put on the public domain with the direction to join their duty within stipulated time mentioned in the appointment letter. The joining time has already expired therein despite of given ample time.
