**Subject: Cancellation of candidature for the post of TGT (Punjabi)F – Non-fulfillment of Essential criteria related to age & category.**


Whereas, the candidature of the following (details as under) nominated candidates for the post of Trained Graduate Teacher (Punjabi)F, Post Code 810/24, are found ineligible for taking/availing benefit of age relaxation/category with reference to the Recruitment Rules and the terms and conditions stipulated in the Advertisement Notice No.02/24.

And whereas, upon examination of the term & condition mentioned in the respective advertisement and upon receipt of the certificates/documents submitted/uploaded by the candidates, it has been observed that the above mentioned candidates do not eligible for taking/availing any relaxation/benefit against their category or age related certificate according to the term & condition **stipulated in the vacancy advertisement of the said post.**

And whereas, the matter was examined in detail in light of the prescribed deemed rule and RRs and also thorough examination of the category/age relaxation related documents submitted by the candidates and it has been evident that the aforesaid candidate held ineligible for the appointment as not being in conformity with the prescribed terms & conditions of the vacancy advertisement.

Now, therefore, in view of the above facts and findings, the candidature of the aforesaid candidates for the post of TGT (Punjabi)F post code 810/24 are hereby cancelled/rejected with immediate effect as the candidates do not have proper reservation benefit certificate/age relaxation benefit certificate as per the required essential qualification for the above said post as per below, wherefore the candidature of the above mentioned candidates would no longer treated as a eligible candidates for the said post. Henceforth, the candidatures of the aforesaid candidates are hereby cancelled/rejected outright as their respective reservation certificates related to age/category not lived up to the mark.
