During the DV held on 27/02/2026 while filling up of Acceptance of Offer of Appointment the candidate, Sh. Gurpreet Singh, vide point no. 10 (details of post(s) held previously, has submitted his details as "N.A" in all the columns, which means it has been mentioned by him that he is not in govt. service by mentioning "N.A." in all the columns. Further even in the Attestation Form point No. 11(a) also has submitted his details as "N.A" in all the columns, which means it has been mentioned by him that he is not in govt. service by mentioning "N.A." in all the columns.

Sh. Gurpreet Singh, on successful verification was issued medical examination letter and was further appointed to the post of TGT Punjabi (M) vide order No.DE.3(65)/DRC(E-III)/TGT Punjabi (Male)/2025/345-357, posting ID 20260040 dt.01/04/2026, with the direction to join his place of posting within one month latest by 01/05/26, failing which his appointment shall stand cancelled.

Sh. Gurpreet Singh has submitted an application dt. 27/04/2026, addressed to DDE (DRC), and informed that presently he is working with Education Department, Haryana and there is a Court Case on that Recruitment and also requested to grant further three months extension to join his duties for the post of TGT Punjabi (Male).

Sh. Gurpreet Singh, was given a Show Cause Notice by this office vide no. DE.3(65)/DRC(E-III)/TGT/Punjabi (Male)/2025/478 dated 08/05/2026 asking for his explanation for concealment of facts regarding his working in with Education Department, Haryana. Now, the candidate has given his reply and he also submitted an affidavit in this regard dated 20/05/2026.

On scrutiny of his reply to the Show-Cause Notice and affidavit dated 08/05/2026, he is intimated that it would not be feasible to entertain any further extension to the candidate to join his post as TGT Punjabi, Male, in post code 810/24, he was allotted Yamuna Vihar =, Block C, No.1 SBV School Id 1104009 vide order No.DE.3(65)/DRC(E-III)/TGT Punjabi (Male)/2025/345-357, posting ID 20260040 dt.01/04/2026, and he should join immediately without any further delay or else his candidature shall be cancelled without any further notice.
