Sub:- Withdrawal of Cancellation Order dated 28.02.2024 in respect of Ms. Anupama Jadaun (D.O.B:- 12/05/1989), Roll No. 328055100038 nominated candidate of 'EWS' category for the post of TGT (Sanskrit) Female under post code 55/21.

Whereas, Ms. Anupama Jadaun (D.O.B:- 12/05/1989), Roll No. 328055100038, a candidate of EWS category was provisionally nominated to the post of TGT (Sanskrit) Female under post code 55/21 in 'Main Merit' of 'EWS' category by DSSSB vide Result Notice No. 167 dated 16.08.2022 in pursuance of Vacancy Notice Advertisement No.03/21 dated 12.05.2021.

Whereas, aforesaid candidate was not able to produce valid EWS Certificate issued before cutoff date, therefore, her candidature for the post of TGT (Sanskrit) Female was rejected vide Cancellation Order No. F.No. DE.3(42)/DRC/E-III/TGT (Sanskrit)/Female/2022/2925-28 dated 28/02/2024.

Whereas, Ms. Anupama Jadaun, aggrieved with the cancellation order dated 28/02/2024 filed in O.A. 3452/2024 (Anupama Jadaun vs Department of Education), Hon'ble CAT vide order dated 16/01/2025 passed the directions to consider for appointment if found suitable, of post code 55/21 and WPC 6403/2025 disposed on 30.10.2025, compliance covered under WPC 2814/2024, GNCTD vs Rishikesh Sharma.

Whereas, the Hon'ble Delhi High Court has upheld the orders/directions passed in the similar matters in r/o other post code(s), by the Hon'ble CAT in O.A. No. 1524/24 (in Anju & Ors. case) and 1551/2022 (in Rishikesh Sharma case), vide judgement dated 19.07.2025 in W.P.(C) 2814/2024 (filed by GNCTD & Ors. and clubbed with WPC Nos. 15889/23, 15912/23, 15953/23, 16440/23 & 16552/2023) by dismissing the filed writ petition(s) by Hon'ble High Court of Delhi. The Hon'ble Supreme Court of India has also upheld the order/judgement passed in WP (C) No. 2814/2024 vide judgement dated 04.09.2025 in SLP (C) No. 13026/2025 (filed by DSSSB & Anr.). Whereas, the candidates were asked by the Department to attend the Office in person to submit all the documents and testimonials and specifically the original EWS certificates for the last 03 financial years i.e. 2019-20, 2020-21 and 2021-22 alongwith one set of duly self attested documents vide Memorandum number — F.No. DE.3(42)/DRC/E-III/TGT(SKT)/Female/2022/05 dated 05/02/2026. However, all the requisite documents were submitted except

EWS certificate for the session 2019-20, on scheduled day i.e. 13.02.2026 and same are accepted by the Department. However, in CP No. 41/2025 Learned CAT has directed non — availability of the EWS certificate for the financial year 2019-20 shall not operate as a ground to deny consideration of the applicant's candidature, and the respondents shall proceed in accordance with the directions already issued by this Tribunal. Further, directed to implement the directions of this Tribunal in their true spirit and complete the process of verification of documents and consideration of the applicant's candidature expeditiously in accordance with the advertisement and the earlier order passed by this Tribunal.

Now, therefore, in compliance with the directions of the Hon'ble CAT/ Courts as aforementioned and with the approval of the Competent Authority, the Cancellation Order Order No. F.No. DE.3(42)/DRC/E-III/TGT (Sanskrit)/Female/2022/2925-28 dated 28/02/2024 is hereby withdrawn with retrospective effect of issued "Memorandum dated 17.11.2022 towards Offer of Appointment".

This issues with the prior approval of the Competent Authority.
