No. F. 27/1/90-Edn.1800.—In exercise of the powers conferred by the proviso to article 309 of the Constitution read with the Government of India, Ministry of Home Affairs Notification No. F. 27/59-Hlm (i), dated the 13th July, 1959, the Administration of the Union Territory of Delhi is pleased to make the following amendment in the Schedule annexed to this Administration's notification No. F. 2(16)/68-S.11, dated 23-12-71, as amended from time to time, containing rules regarding the method of recruitment and qualifications necessary for appointment to the post of Laboratory Assistant in the Directorate of Education, Delhi namely :—

AMENDMENT

In the said schedule, for the existing entries under column 11 (in case of regt. by promotion/deputation/transfer, grades from which promotion/deputation/transfer to be made), the following shall be substituted, namely :—

Column 11. Promotion

Group 'D' employees of Delhi Administration having three years service in the grade rendered after appointment thereto on a regular basis who are matriculate or equivalent/Higher Secondary with Science (Physics & Chemistry with Practical or Physics, Chemistry & Biology with practical) and employees who are matriculate or equivalent/Higher Secondary without Science; provided they have successfully undergone a three months Orientation Course in Science conducted by the Directorate of Education.

Note:- 1. The age limit for direct recruit. will be relaxable in case of Schedule Caste/Schedule Tribes candidates and other special categories of persons in accordance with the general orders issued from time to time by the Central Govt.

2. Nothing in these rules shall affect reservation and other concessions required to be provided for Schedule Castes and Schedule Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. from time to time.
 3. No male candidate who has more than one wife living or no female candidate who has married a person already married to a wife living shall be eligible for appointment in case of direct recruit. provided that the Administrator, Delhi may after being satisfied that there are special grounds for doing so, exempt any such candidate from the operation of this rule.
 4. Where the Administrator is of the opinion that it is necessary or expedient to do so, he may by order for reasons to be recorded in writing relax any of the provisions of these rules with respect to any person, class or category of persons/posts.
