Consequent upon nomination through Delhi Subordinate Services Selection Board for the post of TGT-Maths (Female) vide letter No.F.1 (193)/DSSSB/P&P/13/Part File-II/2247 dated 28.10.2024 & Supplementary Result Notice no. 952 dated 27.09.2024 and in compliance of Ld. CAT order dated 11.01.2023 in O.A No. 1150/2019 titled as Ms. Jyotsna Gosa Vs GNCTD & Ors, which was further upheld by the Hon'ble High Court of Delhi vide order dated 13.10.2025 in W.P(C) No. 6457/2023.
