ORDER

Sub: Withdrawal of Cancellation Order dated 24.09.2024 in respect of Mr. Yogendra Vyas (DOB-05/01/1991), Roll No. 121203401223, a nominated candidate of 'EWS' category for the post of TGT (Hindi) – Male under post code 34/21.

Whereas, Mr. **Yogendra Vyas (DOB-05/01/1991), Roll No. 121203401223**, a candidate of EWS category was provisionally nominated to the post of TGT (Hindi) – Male under post code 34/21 in 'Reserve Panel' of 'EWS' category by DSSSB vide Supplementary Result Notice No. 21 dated 28.05.2024 in pursuance of Vacancy Notice Advertisement No.02/21 dated 12.05.2021.

Whereas, aforesaid candidate was not able to produce valid EWS Certificate issued before cutoff date, therefore, his candidature for the post of TGT (Hindi) – Male was rejected vide Cancellation Order F. No.DE.3 (28)/DRC/E-III/TGT(Hindi)/Male/2022/6191-6194 dated 24.09.2024.

Whereas, Mr. Yogendra Vyas, aggrieved with the cancellation order dated 24.09.2024, filed an O.A. No. 4519/2024 with M.A. 4292/2024 with Hari Prasad Sharma, titled "Yogendra Vyas and Hari Prasad Sharma Vs GNCTD & Ors." of post code 34/21 before Hon'ble CAT. Hon'ble CAT vide order dated 24.04.2025 passed the directions to consider for appointment, if found suitable on the basis of judgement dated 08.08.2023 in OA No. **1524/2022** - clubbed with OA Nos. 1525/22, 1754/22, 1356/2022 & 1360/2022). Apart this, the Hon'ble CAT also allowed another O.A. No. 1551/2022, titled "Rishikesh Sharma versus GNCTD & DSSSB" in similar matter for other post code.

Whereas, the Hon'ble Delhi High Court has upheld the orders/directions passed in the similar matters in r/o other post code(s), by the Hon'ble CAT in O.A. No. 1524/24 (in Anju & Ors. case) and 1551/2022 (in Rishikesh Sharma case), vide judgement dated 19.07.2025 in W.P.(C) 2814/2024 (filed by GNCTD & Ors. and clubbed with WPC Nos. 15889/23, 15912/23, 15953/23, 16440/23 & 16552/2023) by dismissing the filed writ petition(s) by Hon'ble High Court of Delhi. The Hon'ble Supreme Court of India has also upheld the order/judgement passed in WP (C) No. **2814/2024** vide judgement dated 04.09.2025 in **SLA (C) No. 13026/2025** (filed by DSSSB & Anr.)

Whereas, the candidates were asked by the Department to attend the Office in person to submit all the documents and testimonials and specifically the original EWS certificates for the last 03 financial years i.e. 2019-20, 2020-21 and 2021-22 alongwith one set of duly self attested documents vide Memorandum number – F.No. DE. 3 (28)/DRC/E-III/TGT (Hindi)/MALE/2022/06 dated 05.02.2026. All the requisite documents were submitted on scheduled day i.e. 13.02.2026 and same are accepted by the Department.

Now, therefore, in compliance the directions of the Hon'ble CAT/ Courts as aforementioned and with the approval of the Competent Authority, the Cancellation Order No. F. No.DE.3 (28)/DRC/E-III/TGT(Hindi)/Male/2022/6191-6194 dated 24.09.2024 in r/o Mr. Yogendra Vyas is hereby **withdrawn with retrospective effect** of issued "Memorandum dated 03.06.2024 towards Offer of Appointment".

This issues with the prior approval of the Competent Authority.
